## A BILL FOR AN ACT

To appropriate from the General Fund of the Federated States of Micronesia, a sum of \$3.5 million for the purpose of funding public projects and social programs in the four States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. The sum of \$3.5 million, or so much thereof is

18	All funds appropriated by this act shall be allotted, managed,
19	administered and accounted for in accordance with applicable laws,
20	including, but not limited to the Financial Management Acts of
21	each of the State, the Financial Management Act of 1979 and the
22	amended Compact of Free Association between the United States
23	Government and the Government of the Federated States of
24	Micronesia and its related agreements. The allottee shall be
25	responsible for ensuring that these funds, or so much thereof as

may be necessary, are used solely for the purpose specified in
   this act, and that no obligations are incurred in excess of the
 3 sum appropriated. The allottee of the funds appropriated under
 4 subsections (4)(a), (c), (d), (e) and (f) of section 1 of this act
   shall be the Chuuk State Commission on Improvement Project. The
   allottee of the appropriated funds under subsection (4)(b) of
 7 section 1 of this act shall be the Mortlocks Commission. [The
   allottee of funds appropriated under subsection (4) (e) of section
   1 of this act shall be Mayor of Polle]. The allottee of funds
   appropriated under subsections (1)(a)(b), (2)(a)(b), 3(a)(b)(c)

   and (d) of this act shall be the President of the Federated States
