A BILL FOR AN ACT

To amend section 8 of Public Law No. 15-55, as amended, to extend lapse date of funding for National Maritime boundary Delineation, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 8 of Public Law No. 15-55, is hereby
- 2 amended to read as follows:
- 3 "Section 12. Allotment and management of funds and

- (1) <u>General Provisions</u>.
- (a) All funds appropriated by this act shall be allotted, managed, administered and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979 and the amended Compact of Free Association between the United States Government and the Government of the Federated States of Micronesia and its related agreements.
 - (b) The allottees shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum appropriated.
- 18 (2) <u>Allottees</u>. The allottee of the funds appropriated
 19 by this act are as follows:

1	(a) Section 2 - the allottee of these funds shall
2	be the President of the Federated States of Micronesia;
3	(b) Section 3 - the allottee of these funds shall
4	be the Speaker of the Congress of the Federated States
5	of Micronesia;
6	(c) Section 4 - the allottee of these funds shall
7	be the Chief Justice of the Supreme Court of the
8	Federated States of Micronesia;
9	(d) Section 5 - the allottee of these funds shall
10	be the Public Auditor of the Federated States of
11	Micronesia;
12	(e) Sections 6 through 9 - the allottee of these
13	funds shall be the President of the Federated States of
14	Micronesia, EXCEPT THAT for the following subsections of
15	sections 8 through 9 of this act:
16	(i) Section 8 subsection (13)(a) through (d)
17	- the allottee of these funds shall be the Chief Justice
18	of the respective state,
19	(ii) section 9(1)(a) through (c) - the
20	allottee of these funds shall be the President of the
21	College of Micronesia-FSM.
22	<u>Lapse Date</u> . The authority of the allottee to obligate
23	funds appropriated by this act shall lapse as of
24	September 30, 2009, EXCEPT the funds appropriated under
25	section 8 subsection (13)(j) and section 9 of this act
