A BILL FOR AN ACT

To appropriate the sum of \$199,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2010, for the purpose of funding Economic and Social Projects and Programs in the States of Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

10	Section 2. Allotment and management of funds and lapse date.
11	All funds appropriated by this act shall be allotted, managed,
12	administered and accounted for in accordance with applicable
13	laws, including, but not limited to, the Financial Management Act
14	of 1979. The allottee shall be responsible for ensuring that
15	these funds, or so much thereof as may be necessary, are used
16	solely for the purpose specified in this act, and that no
17	obligations are incurred in excess of the sum appropriated. The
18	allottee of the funds appropriated under Section 1 of this act
19	shall be the President of the Federated States of Micronesia,
20	PROVIDED HOWEVER that the allottee of funds appropriated in
21	Section 1(3)(a), (b), (d) and (e) of this act shall be the Chuuk
22	State Commission on Improvement Project (CSCIP). The authority
23	of the allottee to obligate funds appropriated by this act shall
24	not lapse.
25	Section 3. This act shall become law upon approval by the
