A BILL FOR AN ACT

To appropriate funds made available by the "FSM Infrastructure Sector Grant - Fiscal Year 2010 - AED/PE" grant of \$9,250,000 for the purpose of funding the Architecture, Engineering and Design/Preliminary Engineering of Public Infrastructure Projects for the State and National Governments of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. <u>Appropriation</u>. There is hereby appropriated
- 2 from the General Fund of the Federated States of Micronesia
- 3 the sum of \$9,250,000, or so much thereof as may be necessary,
- 4 for the purpose of funding the Architecture, Engineering and
- 5 Design/Preliminary Engineering of Public Infrastructure
- 6 Projects for the State and National Governments of the
- 7 Federated States of Micronesia through the fiscal year ending
- 8 September 30, 2010, as designated in the "FSM Infrastructure
- 9 Sector Grant Fiscal Year 2010 AED/PE" grant of \$9,250,000.
- 10 Of the funds appropriated herein, the total sum shall be
- 11 deemed to come from funds available under the "FSM
- 12 Infrastructure Sector Grant Fiscal Year 2010 AED/PE."
- 13 Section 2. Public Infrastructure Projects of Chuuk
- 14 State. Of the sum appropriated by Section 1, \$1,960,000 is
- 15 apportioned for the purpose of funding the Architecture,
- 16 Engineering and Design/Preliminary Engineering of Public
- 17 Infrastructure Projects for Chuuk State, subject to the
- 18 procedures for submission and approval of such projects

- 1 through JEMCO.
- 2 Section 3. <u>Public Infrastructure Projects of Kosrae State</u>.
- 3 Of the sum appropriated by Section 1, \$1,644,000 is apportioned
- 4 for the purpose of funding the Architecture, Engineering and
- 5 Design/Preliminary Engineering of Public Infrastructure Projects
- 6 for Kosrae State, subject to the procedures for submission and
- 7 approval of such projects through JEMCO.
- 8 Section 4. Public Infrastructure Projects of Pohnpei State.
- 9 Of the sum appropriated by Section 1, \$2,688,000 is apportioned
- 10 for the purpose of funding the Architecture, Engineering and
- 11 Design/Preliminary Engineering of Public Infrastructure Projects
- 12 for Pohnpei State, subject to the procedures for submission and
- 13 approval of such projects through JEMCO.
- 14 Section 5. Public Infrastructure Projects of Yap State. Of
- 15 the sum appropriated by Section 1, \$756,000 is apportioned for
- 16 the purpose of funding the Architecture, Engineering and
- 17 Design/Preliminary Engineering of Public Infrastructure Projects
- 18 for Yap State, subject to the procedures for submission and
- 19 approval of such projects through JEMCO.
- 20 Section 6. Public Infrastructure Projects for the National
- 21 <u>Government of the Federated States of Micronesia</u>. Of the sum
- 22 appropriated by Section 1, \$2,202,000 is apportioned for the
- 23 purpose of funding the Architecture, Engineering and
- 24 Design/Preliminary Engineering of Public Infrastructure Projects
- 25 for the National Government of the Federated States of

- 1 Micronesia, subject to the procedures for submission and approval
- 2 of such projects through JEMCO.
- 3 Section 7. Change in Apportionment of Funds. The President
- 4 of the Federated States of Micronesia, upon consultation and
- 5 consent of the affected States, may increase or decrease the
- 6 apportionment set forth in Sections 2 through 6, provided that
- 7 the total shall not exceed the amount of the grant.
- 8 Section 8. Allotment and Management of Funds and Lapse Date.
- 9 (1) General Provisions.
- 10 (a) All funds appropriated by this act shall be
- 11 allotted, managed, administered and accounted for in accordance
- 12 with applicable laws, including, but not limited to, Public Law
- 13 No. 13-72, the Financial Management Act of 1979 and the amended
- 14 Compact of Free Association between the Government of the United
- 15 States and the Government of the Federated States of Micronesia
- 16 and its related agreements.
- 17 (b) The allottee shall be responsible for ensuring
- 18 that these funds, or so much thereof as may be necessary, are used
- 19 solely for the purposes specified in this act and the grant award,
- 20 and that no obligations are incurred in excess of the sum
- 21 appropriated.
- 22 (2) Allottee. For funds appropriated in this act, the
- 23 allottee shall be the President of the Federated States of
- 24 Micronesia, or his designee.
- 25 (3) Lapse Date. The authority of the allottee to obligate

         Section 9. <u>Effective date</u>. This act shall become law
 4 upon approval by the President of the Federated States of
 5 Micronesia or upon its becoming law without such approval.
