A BILL FOR AN ACT

To further amend Section 3 of Public Law No. 15-55, as amended, to modify the use of funds previously appropriated therein for the operation of the Legislative Branch of the National Government of the Federated States of Micronesia for the fiscal year 2009, and for other purposes.

- BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 3 of Public Law No. 15-55, as amended, by 1 Section 1. Public Laws Nos. 15-55 and 15-69, is hereby further amended to read as follows: 4 "Section 3. Operating Expenses of the Legislative The sum of \$3,073,003 or so much thereof as may 5 be necessary, is hereby appropriated from the General 6 Fund of the Federated States of Micronesia for the 7 fiscal year ending September 30, 2009, for the 8 9 operations of the Legislative Branch of the National Government during fiscal year 2009. 10 appropriated by this section shall be apportioned as 11 follows: 12
 - (1) Speaker and Members.
 - \$1,457,771 or so much thereof as may be necessary, for 14 the operations of the Office of the Speaker and Members 15 of the Congress of the Federated States of Micronesia 16 The sum appropriated herein during fiscal year 2009. 17

(i) Kosrae Delegation Office\$ 70,000
(ii) Pohnpei Delegation Office . 140,000
