
Dear Speaker Figir:

I am pleased to transmit the following Congressional Act No. 16-15 which I have signed to become Public Law No. 16-13 pursuant to section 22, title IX of the constitution:

“AN ACT TO APPROPRIATE THE SUM OF \$80,000 FROM THE GENERAL FUND OF THE FEDERATED STATES OF MICRONESIA FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2010, TO BE CHANNELED THROUGH THE MICRONESIA RED CROSS, FOR THE PURPOSE OF CONTRIBUTING TO THE INTERNATIONAL RELIEF EFFORT FOR THE RECENT DISASTERS IN THE PHILIPPINES, VIETNAM, INDONESIA, TONGA, SAMOA, AMERICAN SAMOA, AND OTHER DISASTERS IN THE ASIA-PACIFIC REGION, AND FOR OTHER PURPOSES.”

CONGRESSIONAL BILL NO. 16-50, C.D.1

PUBLIC LAW No. 16-13

AN ACT

To appropriate the sum of \$80,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2010, to be channeled through the Micronesia Red Cross, for the purpose of contributing to the international relief effort for the recent disasters in the Philippines, Vietnam, Indonesia, Tonga, Samoa, American Samoa, and other disasters in the Asia-Pacific region, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$80,000, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending
4 September 30, 2010, for the purpose of contributing to the
5 international relief effort for the recent disasters in the
6 Philippines, Vietnam, Indonesia, Tonga, Samoa, American Samoa, and
7 other disaster-stricken countries in the Asia-Pacific region.
8 These funds shall be channeled through the Micronesia Red Cross.

9 Section 2. Allotment and management of funds and lapse date.

10 (1) All funds appropriated by this act shall be allotted,
11 managed, administered, and accounted for in accordance with
12 applicable law, including, but not limited to, the Financial
13 Management Act of 1979. The allottee of the funds appropriated by
14 this act shall be the President of the Federated States of
15 Micronesia, or his designee. The allottee shall be responsible
16 for ensuring that these funds, or so much thereof as may be
17 necessary, are used solely for the purpose specified in this act,

1 and that no obligations are incurred in excess of the sum
2 appropriated.

3 (2) The authority of the allottee to obligate funds
4 appropriated by this act shall lapse as of December 1, 2010.

5 Section 3. This act shall become law upon approval by the
6 President of the Federated States of Micronesia or upon its
7 becoming law without such approval.
