## AN ACT

To appropriate the sum of \$199,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2010, for the purpose of funding Economic and Social Projects and Programs in the States of Kosrae, Pohnpei and Chuuk, and for other purposes. BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 1. The sum of \$199,000, or so much thereof as may be 1 2 necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending 3 4 September 30, 2010, for the purpose of funding Economic and Social Projects and Programs in the States of Kosrae, Pohnpei and Chuuk. 5 The funds appropriated under this section shall be apportioned as 6 7 follows: 8 (1) State of Kosrae .....\$ 5,000 9 (a) Project Management ..... 5,000 (2) State of Pohnpei ..... 10 30,000 11 (a) Election District No. 1 12 (i) Project Management ..... 30,000 13 (3) State of Chuuk ..... 164,000 14 (a) At-Large ..... 49,000 15 (i) Public Facilities ..... 34,000 16 (ii) Project Management ..... 15,000 17 (b) Election District No. 1 ..... 14,000 18 (i) Project Management ..... 11,000 19 (ii) CSCIP operation ..... 3,000 20 (c) Election District No. 2.....\$ 35,000

10	Section 2. <u>Allotment and management of funds and lapse date</u> .		
11	All funds appropriated by this act shall be allotted, managed,		
12	administered and accounted for in accordance with applicable laws,		
13	including, but not limited to, the Financial Management Act of		
14	1979. The allottee shall be responsible for ensuring that these		
15	funds, or so much thereof as may be necessary, are used solely for		
16	the purpose specified in this act, and that no obligations are		
17	incurred in excess of the sum appropriated. The allottee of the		
18	funds appropriated under Section 1 of this act shall be the		
19	President of the Federated States of Micronesia, PROVIDED HOWEVER		
20	that the allottee of funds appropriated in Section 1(3)(a), (b),		
21	(d) and (e) of this act shall be the Chuuk State Commission on		
22	Improvement Project (CSCIP). The authority of the allottee to		
23	obligate funds appropriated by this act shall not lapse.
