A RESOLUTION

Approving and accepting the \$200,000,000\$ financial grant, and all the terms and conditions of said grant, from the Government of Japan to the Government of the Federated States of Micronesia.

- 1 WHEREAS, the Government of Japan extended to the Government
- 2 of the Federated States of Micronesia economic cooperation grant
- 3 (the "Grant") in the amount of 200,000,000; and
- 4 WHEREAS, the purpose of the grant is to contribute to the
- 5 promotion of the economic structural adjustment efforts by the
- 6 Government of the Federated States of Micronesia as well as
- 7 mitigation of the economic difficulties, including indebtedness,
- 8 of the Federated States of Micronesia; and
- 9 WHEREAS, both the Government of the Federated States of
- 10 Micronesia and the Government of Japan exchanged diplomatic notes
- 11 on January 21, 2009 concerning the Grant; and
- 12 WHEREAS, the Grant explicitly provides that the Government of
- 13 the Federated States of Micronesia shall take necessary measures:
- 14 "(a) to secure that the Grant and its accrued interest shall be
- 15 complete disbursed from the Account to be ready for the
- 16 procurement of goods or services within the period of twelve
- 17 months after the date of the execution of the Grant unless the
- 18 period is extended by mutual consent between the authorities
- 19 concerned of the two Governments and to refund the amount
- 20 remaining in the Account after the period to the Government of
- 21 Japan; (b) to ensure that customs duties, internal taxes and other

- 1 fiscal levies which may be imposed in the Federated States of
- 2 Micronesia with respect to the purchase of the products and
- 3 services referred to in sub-paragraph (1) of paragraph (2). shall
- 4 not be borne by the Grant; (c) to ensure that the Grant and its
- 5 accrued interest be used properly and effectively for promotion of
- 6 the economic structural adjustment efforts as well as mitigation
- 7 of the economic difficulties, including indebtedness, of the
- 8 Federated States of Micronesia; (d) to present to the Government
- 9 of Japan a report prepared in a written form acceptable to the
- 10 Government of Japan on the transactions on the Account together
- 11 with copies of contracts, vouchers and other documents concerning
- 12 the relevant transactions without delay when the Grant and its
- 13 accrued interest are completely drawn in accordance with the
- 14 provisions of sub-paragraph (2) of paragraph 3., or when the
- 15 period for the use of the Grant and its accrued interest expires
- 16 in accordance with the provisions of (a) above, or upon request by
- 17 the Government of Japan; and (e) to give due environmental and
- 18 social consideration in the uses of the Grant"; and
- 19 WHEREAS, section 210(2) of title 55 of the Code of the
- 20 Federated States of Micronesia requires foreign finance assistance
- 21 to be approved by Congress by resolution; now, therefore,
- BE IT RESOLVED by the Sixteenth Congress of the Federated
- 23 States of Micronesia, First Special Session, 2009, that the
- 24 ¥200,000,000 financial Grant from the Government of Japan,
- 25 including all the terms and conditions such as those as are
