## A RESOLUTION

Requesting the President of the Federated States of Micronesia to convene an immediate National and State Leadership Conference.

- 1 WHEREAS, concerns have been raised toward the Strategic
- 2 Development Plan (SDP), because under the terms of the amended
- 3 Compact, the SDP is to be a rolling plan which will be continually
- 4 reviewed and updated; and
- 5 WHEREAS, the Executive Branch of the National Government has
- 6 undertaken to continue working in conjunction with each of the
- 7 States of the Federated States of Micronesia to refine the SDP but
- 8 failed to achieve a coordinated effort from the states in refining
- 9 the SDP as was envisioned;
- 10 WHEREAS, there is an immediate need for the five governments
- 11 to refine the SDP insofar as Compact grant funds are involved; and
- 12 WHEREAS, the Trust Fund for the people of the Federated
- 13 States of Micronesia was created to contribute to the long-term
- 14 budgetary self reliance of the Government of the FSM and to
- 15 provide the Government of the FSM with an ongoing source of
- 16 revenue after fiscal year 2023; and
- 17 WHEREAS, it is imperative that the FSM National and State
- 18 Governments make every effort to assess the Trust Fund's
- 19 performance against a sensible goal; and
- 20 WHEREAS, the FSM is required under title one, section 214 of
- 21 the Amended Compact to submit a report to the President of the
- 22 U.S. on the use of sector grant assistance and the progress in

fulfilling the mutually agree-upon program and economic goals; and WHEREAS, the National and State Governments must come together and discuss how to expedite and fulfill this reporting requirement under the Amended Compact; and 5 WHEREAS, concerns have been raised on the use and power to appropriate the Supplemental Education Grant and the sector grant 7 under the Amended Compact; and WHEREAS, such concerns have delayed the utilization of said 8 funds; and 10 WHEREAS, there is an urgent convening of a leadership conference to address and resolve any concerns and/or problems 11 12 relating to the SDP, Trust Fund, Tax Reform, the Reporting requirement under title 1, section 214 of the Amended Compact and 13 the use of the SEG and sector grant assistance; now, therefore, 15 BE IT RESOLVED by the Sixteenth Congress of the Federated States of Micronesia, Second Special Session, 2009, that the 16 17 Congress hereby requests the President of the Federated States 18 of Micronesia to convene a leadership conference to be held in 19 the State of Pohnpei, and to commence during the Second Regular Session of the 16<sup>th</sup> congress of the Federated States of 20 21 Micronesia to consider the referenced subject matters, and 22 other relevant matters that may surface; and
