A RESOLUTION

Approving and accepting the agreement on financial assistance from the Government of the United States of America in the amount of \$48,200, including all the terms and conditions of the assistance.

- 1 WHEREAS, the Government of the United States through the USDA
- 2 extended, and FSM accepted, a competitive grant (the "Grant") in
- 3 the amount of \$48,200 as evidenced by a letter dated August 18,
- 4 2008 from the State and Private Forestry, USDA, Forest Service,
- 5 Region 5; and
- 6 WHEREAS, the Grant was extended to the FSM upon the approval
- 7 of FSM's application for federal assistance, entitled: "Protecting
- 8 Pohnpei's Watershed Forest Reserve" which was submitted during FY
- 9 2008; and
- 10 WHEREAS, the activities to be funded by the proceeds of the
- 11 Grant are those to be undertaken in the State of Pohnpei under the
- 12 Forest Stewardship Program, and are designed to protect
- 13 biodiversity and water resources in partnership with the
- 14 communities; and
- WHEREAS, pursuant to section 210(1)(b) of title 55 of the
- 16 Code of the Federated States of Micronesia the Grant constitutes a
- 17 "foreign financial assistance", and the acceptance thereof
- 18 constitutes the "agreement" as the term is understood under
- 19 section 210(1)(a) of title 55 of the Code of the Federated States
- 20 of Micronesia; and
- 21 WHEREAS, pursuant to section 210(2) of title 55 of the Code

1 of the Federated States of Micronesia, no agreement shall be 2 valid, and no funds may be received pursuant to such agreement, 3 unless and until Congress approves the agreement by resolution; 4 now, therefore, BE IT RESOLVED by the Sixteenth Congress of the Federated 5 States of Micronesia, Third Regular Session, 2010, that the \$48,200 Grant from the Government of the United States of America 8 for the benevolent assistance and gesture of further strengthening 9 friendly and cooperative relations including all the terms and 10 conditions of the assistance is hereby approved and accepted; and 11 12 13 14 15 16 17 18 19 20 21 22 23 24 BE IT FURTHER RESOLVED that certified copies of this 25
