To respectfully request the members of the United States Congress to support the reinstatement of the eligibility for Medicaid benefits to the citizens of the Freely Associated States.

- 1 WHEREAS, the Compact of Free Association is a treaty between
- 2 the Federated States of Micronesia and the United States of
- 3 America; and
- 4 WHEREAS, under the Compacts of Free Association, the
- 5 citizens of Freely Associated States, including the Federated
- 6 States of Micronesia, are allowed to travel, reside, attend school
- 7 and work in the United States or any of its territories or
- 8 possessions; and
- 9 WHEREAS, since the inception of the original Compacts,
- 10 citizens of Freely Associated States have enjoyed the privileges
- 11 and assistance relating to Medicaid and student financial
- 12 assistance, among others; and
- 13 WHEREAS, the Personal Responsibility and Work Opportunity
- 14 Reconciliation Act (PRWORA) was enacted by the United States in
- 15 1996, making citizens of Freely Associated States ineligible for
- 16 certain federally funded programs, including Medicaid; and
- 17 WHEREAS, the ineligibility of citizens of Freely Associated
- 18 States for Medicaid benefits has contributed to enormous financial
- 19 constraints for the state and local governments in the areas of
- 20 the United States where huge numbers of citizens of Freely
- 21 Associated States live; and
