

A BILL FOR AN ACT

To appropriate the sum of \$363,608 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2010, for the purpose of funding the activities and programs of the Department of Education for the fiscal year ending September 30, 2010, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Appropriation. There is hereby appropriated from
2 the General Fund of the Federated States of Micronesia the sum of
3 \$363,608, or so much thereof as may be necessary, for the purpose
4 of funding the activities and programs of the Department of
5 Education through the fiscal year ending September 30, 2010. The
6 total funds appropriated therein shall be deemed to come from
7 funds available to the national Government from the Supplemental
8 Education Grant for fiscal year 2006 (SEG 06).

9 Section 2. Use of funds. The funds appropriated in section 1
10 shall be used in accordance with the terms of the Grant Award, and
11 any modifications, restrictions, conditions and authorizations as
12 may be approved or required by the Government of the United States
13 as the Grantor of the Supplemental Education Grant funds.

14 Section 3. Reimbursement. The National Government of the
15 Federated States of Micronesia shall identify sources for the
16 reimbursement to the relevant States Governments whose allocations
17 pursuant to section 303, title 55, of the code of the Federated

1 States of Micronesia have been adversely affected by this
2 appropriation.

3 Section 4. Allotment and Management of Funds and Lapse Date.

4 (1) General Provisions.

5 (a) All funds appropriated by this act shall be
6 allotted, managed, administered and accounted for in accordance
7 with applicable laws, including the Financial Management Act of
8 1979 and the amended Compact of Free Association between the
9 Government of the United States and the Government of the
10 Federated States of Micronesia and its related agreements.

11 (b) The allottee shall be responsible for ensuring
12 that these funds, or so much thereof as may be necessary, are
13 used solely for the purpose specified in this act, and that no
14 obligations are incurred in excess of the sum appropriated.

15 (2) Allottee. For funds appropriated in this act, the
16 allottee shall be the President of the Federated States of
17 Micronesia, or his designee.

18 (3) Lapse Date. The authority of the allottee to
19 obligate funds appropriated by this act shall lapse when fully
20 obligated.

1 Section 4. Effective Date. This act shall become law upon
2 approval by the President of the Federated States of Micronesia or
3 upon its becoming law without such approval.
