

A RESOLUTION

To resubmit the nomination of Mr. Akillino H. Susaia to be the Ambassador of the Federated States of Micronesia to the Government of the People's Republic of China, pursuant to section 207 of title 2 of the Code of the Federated States of Micronesia, as amended.

1           WHEREAS, pursuant to section 207 of title 2 of the Code of  
2 the Federated States of Micronesia, as amended, the President of  
3 the Federated States of Micronesia shall nominate Ambassador for  
4 overseas Federated States of Micronesia Embassy's; and

5           WHEREAS, the President of the Federated States of Micronesia  
6 nominates Mr. Akillino H. Susaia as the Ambassador of the  
7 Federated States of Micronesia to the Government of the People's  
8 Republic of China based, inter alia, on his outstanding  
9 educational achievements and coupled with his enormous experiences  
10 in public service, his membership in a series of professional  
11 organizations, his being the current FSM Consul General at the FSM  
12 Consulate Office in Honolulu, Hawaii and numerous other  
13 outstanding credentials which are summarized in his BIODATA, a  
14 copy of which is attached hereto and is incorporated herein by  
15 reference as if fully set forth herein for all purpose; and

16           WHEREAS, Mr. Akillino H. Susaia has experience and  
17 qualifications which make him a suitable candidate as Ambassador  
18 of the Federated States of Micronesia to the Government of the  
19 People's Republic of China; and

20           WHEREAS, the nomination of Mr. Susaia is subject to the

1 advice and consent of the Congress of the Federated States of  
2 Micronesia; and

3 WHEREAS, the Sixteenth Congress of the Federated States of  
4 Micronesia, during its Second Regular Session, 2009, passed  
5 Congressional Resolution No. 16-45, authorizing the FSM President  
6 to resubmit to Congress for confirmation, the nomination of Mr.  
7 Akillino H. Susaia; now, therefore,

8 BE IT RESOLVED by the Sixteenth Congress of the Federated  
9 States of Micronesia, Second Special Session, 2009, that the  
10 nomination of Mr. Akillino H. Susaia as Ambassador of the  
11 Federated States of Micronesia to the Government of the People's  
12 Republic of China be confirmed; and

13 BE IT FURTHER RESOLVED that certified copies of this  
14 resolution be transmitted to the President of the Federated States  
15 of Micronesia, the Secretary of Foreign Affairs, and Mr. Akillino  
16 H. Susaia.
