## A BILL FOR AN ACT

To further amend Public Law No. 17-19, as amended by Public Laws Nos. 17-28 and 17-31, by amending section 3 thereof, to change the use of funds previously appropriated for the fiscal year ending September 30, 2012, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 3 of Public Law No. 17-19, as amended
by Public Laws Nos. 17-28 and 17-31, is hereby amended to read
as follows:

"Section 3. Operating Expenses of the Legislative 4 5 Branch. The sum of \$3,325,228, or so much thereof as may be necessary, is hereby appropriated from the 6 General Fund of the Federated States of Micronesia 7 8 for the fiscal year ending September 30, 2012, for the operations of the Legislative Branch of the 9 National Government during fiscal year 2012. 10 The 11 sum appropriated by this section shall be 12 apportioned as follows:

14 The sum of \$1,490,771, or so much thereof as may be 15 necessary, for the operations of the Office of the 16 Speaker and Members of the Congress of the Federated 17 States of Micronesia during fiscal year 2012. The 18 sum appropriated herein shall be apportioned as 19 follows:
