A BILL FOR AN ACT

To further amend Public Law No. 16-62, as amended by Public Laws Nos. 16-71, 17-05, 17-18 and 17-29, by amending section 5 thereof, to change the use and allottee of certain funds previously appropriated therein to fund public projects and social programs in the State of Chuuk, and for other purposes.
