A BILL FOR AN ACT

To further amend section 805 of title 54 of the Code of the Federated States of Micronesia, as amended by Public Laws Nos. 10-68, 13-21, 13-60, and 15-24, for the purpose of funding the Social Security Retirement Fund with corporate income tax revenues, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 805 of title 54 of the Code of the
- 2 Federated States of Micronesia, as amended by Public Laws Nos.
- 3 10-68, 13-21, 13-60, and 15-24, is hereby further amended to
- 4 read as follows:
- 5 "Section 805. Distribution of revenues.
- 6 (1) (a) The treasurer of the Federated States of 7 Micronesia shall pay eighty percent of the net taxes collected pursuant to section 221(9) of this title 8 9 and, beginning January 1, 2004 and continuing thereafter, fifty percent of all other net taxes 10 collected pursuant to sections 121, 141, and 221 of 11 12 this title into the treasury of the State government 13 to which the taxes are attributable for appropriation by the State legislature. 14
- 15 (b) Twenty-five percent of the amount

 16 remaining, after the transfer of funds pursuant to

 17 subsection (1)(a) of this section, of the net taxes

 18 collected pursuant to subsection 221(1) of this title

shall be placed in an account to be used solely for 1 2 post-graduate school scholarships or full-time post-3 secondary courses of study leading to commercial Federal Aviation Administration (FAA) licenses, 4 ratings and certifications. The allottee of the 5 6 scholarship funds shall be the President of the 7 Federated States of Micronesia or his designee; 8 (c) Beginning October 1, 2011, the treasurer 9 of the Federated States of Micronesia shall pay one 10 hundred percent of net taxes collected pursuant to section 321 of this title to the Federated States of 11 12 Micronesia Social Security Retirement Fund 13 established by section 1001 of title 53 of the Code 14 of the Federated States of Micronesia; 15 [(c)](d) Except as specifically provided in [parts 16 (a) and (b) subsections (1) (a), (1) (b) and, (1) (c) 17 of this [sub]section, all net taxes collected shall 18 be part of the General Fund of the Federated States of Micronesia, subject to appropriation by Congress 19 20 pursuant to title 55 of the Code of the Federated 21 States of Micronesia. (2) 'Net taxes' as used in subsection (1) of this 22 23 section means gross collections of taxes, penalties, 24 interest, or other related charges less refunds."
