## A BILL FOR AN ACT

To establish the Joint Committee on the Future of the Nation and its Secretariat for the purpose of exploring alternatives for the future of the Nation, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Purpose. In anticipation of the termination of
- 2 the financial provisions of the Amended Compact of Free
- 3 Association in 2023, there is hereby established a joint committee
- 4 of the Executive and Legislative branches.
- 5 Section 2. <u>Establishment of the Joint Committee on the</u>
- 6 Future of the Nation. There is hereby created and established a
- 7 joint committee to be known as the Joint Committee on the Future
- 8 of the Nation ("JCFN"), comprising nine members as follows: one
- 9 representative from each of the four States, as appointed by the
- 10 President in consultation with the leadership of each State, and
- 11 four representatives from the Congress of the Federated States of
- 12 Micronesia, one from each congressional delegation. The
- 13 Secretary of Foreign Affairs shall be a member ex officio. He
- 14 shall chair the Joint Committee's first meeting, and organize the
- 15 election of its Chairman and Vice Chairman. Six of the members
- 16 shall constitute a quorum for the transaction of business.
- 17 Decisions shall be made within the Committee by at least five
- 18 concurring votes, with each participating member casting a single
- 19 vote.

- 1 Section 3. Meetings. The JCFN shall hold its first meeting
- 2 at the call of the acting Chairman. Subsequent meetings shall be
- 3 held in accordance with a schedule set by the JCFN covering the
- 4 entire period between the first meeting and the termination of the
- 5 Amended Compact in 2023.
- 6 Section 4. Mandate. The JCFN shall carry out the following
- 7 responsibilities and obligations:
- 8 (1) In consultation with the Congress, set goals and
- 9 objectives in anticipation of the termination of the Amended
- 10 Compact of Free Association;
- 11 (2) Conduct a thorough analysis of all factors
- 12 relating the future of the Nation;
- 13 (3) Develop all necessary strategies and approaches to
- 14 enable the Federated States of Micronesia to explore alternatives
- 15 for the future of the Nation;
- 16 (4) Direct its Secretariat in preparing the
- 17 documentation necessary to accomplish its responsibilities
- 18 hereunder;
- 19 (5) Analyze all economic information available on the
- 20 Federated States of Micronesia, with the aim of identifying the
- 21 FSM's continuing requirement for reasonable, fair, and effective
- 22 financial assistance from all sources from the year 2023 onward;
- 23 (6) Provide reports periodically to the Congress at
- 24 each regular session, and to the Office of the President, on all
- 25 developments, actual or potential, positive or negative, that may

- 1 be related to the future of the Nation, including but not limited
- 2 to new information, actions, communications, domestic and foreign
- 3 policies, bilateral and multilateral plans, as well as periodic
- 4 surveys exploring the value of net benefits to a foreign nation
- 5 from an exclusive security prerogative; and
- 6 (7) Collaborate with the State governments, the
- 7 Department of Foreign Affairs, the Congress, and the Office of the
- 8 President in identifying the nominees for the JCFN whose selection
- 9 will be subject to Congress's expressed approval; and
- 10 (8) Use funds for each separate category of expense
- 11 only up to the aggregate amount of the line-items of the
- 12 corresponding expense category set out in the associated
- 13 appropriations bill or bills approved by Congress, and select and
- 14 hire the personnel needed to staff the Secretariat, as specified
- 15 in section 5 below.
- 16 Section 5. Financing of the JCFN.
- 17 (1) The President shall include the JCFN operations
- 18 budget in his annual budget to Congress;
- 19 (2) The departments and agencies of the Executive
- 20 Branch shall cooperate in providing information and other
- 21 logistical support to the JCFN upon request; and
- 22 (3) The expenses of experts and consultants for the
- 23 governments (state and national) traveling with JCFN shall be
- 24 borne by their agencies of origin.

- 1 Section 6. Establishment of the Secretariat. There is
- 2 hereby created and established a full-time Secretariat for the
- 3 JCFN. The Secretariat shall consist of an Executive Director, an
- 4 Administrative Officer, a staff Counsel, and a secretary, all
- 5 based in Pohnpei. The Secretariat shall have the following
- 6 responsibilities.
- 7 (1) Provide all administrative and logistical support
- 8 to the JCFN, and shall (a) prepare an annual budget for approval
- 9 by the Joint Committee, (b) transmit an approved budget to the
- 10 President to submit, with comments, to the Congress of the
- 11 Federated States of Micronesia;
- 12 (2) Coordinate with the various departments, offices
- 13 and agencies of the FSM and State Governments to collect all
- 14 information and technical input necessary for satisfying its
- 15 responsibilities; and
- 16 (3) As directed by the JCFN, hire professionals
- 17 including an outside developmental economist and other consultants
- 18 with expertise in security or defense policy to assist the Joint
- 19 Committee with any aspect of its responsibilities, particularly
- 20 that are provided under section 4(5) above.
