A BILL FOR AN ACT

To further amend title 54 of the Code of the Federated States of Micronesia, by repealing sections 801, 802, 803, 804 and 805, and inserting new sections 801, 802, and 803 designating sections 801, 802 and 803 as subchapter I, and by enacting new subchapters II, III, IV, V, VI, VII, VIII, IX, X, XI, XII and XIII for the purpose of establishing a new Revenue Administration Act of 2011, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Title 54 of the Code of the Federated States of
- 2 Micronesia is hereby amended by designating sections 801, 802
- and 803 of the chapter as subchapter I entitled "General
- 4 Provisions".
- 5 Section 2. Section 801 of chapter 8 of title 54 of the Code
- 6 of the Federated States of Micronesia, is hereby repealed in its
- 7 entirety and a new section 801 inserted to read as follows:
- 8 "Section 801. Short title.
- 9 This chapter may be cited as the Revenue Administration
- 10 Act of 2011."
- 11 Section 3. Section 802 of chapter 8 of title 54 of the Code
- 12 of the Federated States of Micronesia, is hereby repealed in its
- 13 entirety and a new section 802 inserted to read as follows:
- "Section 802. Definitions.
- 15 Wherever used in this chapter, unless the
- 16 subject matter, context, or sense otherwise
- 17 <u>requires:</u>

1	(1) 'Arrangement' means any contract, agreement,
2	plan, or understanding whether expressed or implied and
3	whether or not enforceable in legal proceedings.
4	(2) 'Associate' has the meaning in section 515 of
5	this title.
6	(3) 'Authority' means the FSM Unified Revenue
7	Authority established under section 711 of this title.
8	(4) 'Board' means the Board of Directors of the
9	Authority appointed under chapter 7 of this title.
10	(5) 'CEO' means the Chief Executive Officer
11	appointed under chapter 7 of this title.
12	(6) 'FSM' means the Federated States of
13	Micronesia.
14	(7) 'Installment of tax' means an installment of
15	tax payable under chapter 5 of this title.
16	(8) 'Late payment interest' means late payment
17	interest imposed under section 891 of this title.
18	(9) 'Net profit tax' means net profit tax imposed
19	under chapter 5 of this title.
20	(10) 'Objection decision' means the decision
21	referred to in section 831(5) of this title.
22	(11) 'Person' means an individual, company,
23	corporation, partnership, unincorporated association or
24	other business entity, trust, estate, government,
25	political subdivision of a government or public

1	international organization.
2	(12) 'Prescribed' means prescribed by the
3	Secretary in regulations.
4	(13) 'President' means the President of the FSM.
5	(14) 'Presumptive tax' means the presumptive tax
6	imposed under chapter 5 of this title.
7	(15) 'Private ruling' means a ruling made under
8	sections 884, 885, 886, 887 and 888 of this title.
9	(16) 'Public ruling' means a ruling made under
10	sections 881, 882, and 883 of this title.
11	(17) 'Representative' means:
12	(a) in the case of an individual under a
13	legal disability, the guardian or manager who receives
14	or is entitled to receive income on behalf, or for the
15	benefit, of the individual;
16	(b) in the case of a company or corporation,
17	the chief executive officer, public officer, managing
18	director, or any director of the company;
19	(c) in the case of a partnership, any
20	partner in the partnership;
21	(d) in the case of a trust, any trustee of
22	the trust;
23	(e) in the case of an unincorporated
24	association or other business entity (other than a
25	company, corporation, or partnership), any individual

1	responsible for accounting for the receipt or payment
2	of moneys or funds on behalf of the association;
3	(f) in the case of the National or a State
4	Government, or a local authority in the FSM, any
5	individual responsible for accounting for the receipt
6	or payment of moneys or funds on behalf of the
7	Government or local authority;
8	(g) in the case of a foreign government,
9	political subdivision of a foreign government, or
10	public international organization, any individual
11	responsible for accounting for the receipt or payment
12	of moneys or funds in the FSM on behalf of the
13	government, political subdivision of the government, or
14	organization;
15	(h) in the case of a non-resident person,
16	any person controlling the person's affairs in the FSM,
17	including any manager of any business of such person
18	and, in relation to customs, the person's customs
19	agent; or
20	(i) in the case of a person to whom section
21	843 of this title applies, the trustee of the person
22	under that section, and includes any person that the
23	CEO has, by notice in writing, declared to be a
24	representative of a person for the purposes of this
25	chapter.

1	(18) 'Revenue law' means:
2	(a) any chapter under this title;
3	(b) a law of the FSM imposing a tax or duty
4	if the law provides that the Authority has the
5	responsibility for administering the tax or duty; and
6	(c) a law of a State imposing a tax that the
7	Authority is permitted to administer by virtue of the
8	laws of such State.
9	(19) 'Revenue officer' means the CEO and any
10	officer of the Authority appointed under section 732 of
11	chapter 7 of this title.
12	(20) 'Secretary' means the Secretary of the FSM
13	Department of Finance and Administration.
14	(21) 'Self-assessment' means a self-assessment of
15	net profits tax, presumptive tax, or VAT.
16	(22) 'Self-assessment return' means a tax return
17	required to be furnished by a self-assessment taxpayer.
18	(23) 'Self-assessment taxpayer' means a person
19	liable for net profit tax, presumptive tax, or VAT.
20	(24) 'State' means a State of the FSM.
21	(25) 'Tax' means any tax, duty, or penalty
22	imposed under a revenue law, and includes an
23	installment of tax and withholding tax.
24	(26) 'Tax assessment' means:
25	(a) an assessment of wages and salaries tax

1	under section 152 of this title;
2	(b) a self-assessment;
3	(c) an assessment under subchapter III of
4	this chapter, including an amended assessment; and
5	(d) an assessment of penalty under section
6	896 of this title.
7	(27) 'Tax decision' means:
8	(a) a tax assessment; or
9	(b) a decision in relation to a revenue law
10	on any matter left to the discretion, judgment,
11	direction, opinion, approval, consent, satisfaction, or
12	determination of the CEO, other than such decision made
13	by the CEO in relation to the making of a tax
14	assessment or to take action on subchapter VI of this
15	<u>chapter.</u>
16	(28) 'Tax period' means:
17	(a) in the case of tax imposed on wages
18	and salaries payable by the employer by withholding
19	under section 132 of this title or payable by the
20	employee under section 138 of this title, the
21	quarter;
22	(b) in the case of the net profits tax or
23	presumptive tax, the tax year;
24	(c) in the case of installments of net
25	profit tax, the period to which the installment

1	<u>relates;</u>
2	(d) in the case of tax withheld from a
3	payment under chapter 5 of this title, the period to
4	which the withholding relates;
5	(e) in the case of VAT, the VAT period; or
6	(f) in any other case, the period for which
7	the tax or duty is reported.
8	(29) 'Tax return' means a return required to be
9	filed under a revenue law.
10	(30) 'Tax warrant' means a warrant issued under
11	section 852 of this title.
12	(31) 'Taxpayer' means a person liable for any tax
13	or duty imposed under a revenue law and includes:
14	(a) an employer liable to withhold tax from
15	a payment of wages and salaries under section 132 of
16	this title; and
17	(b) a person liable to withhold tax from a
18	payment under chapter 5 of this title.
19	(32) 'Taxpayer Identification Number' means a
20	Taxpayer Identification Number issued under section 865
21	of this title.
22	(33) 'VAT' means valued added tax imposed under a
23	revenue Law.
24	(34) 'Wages and salaries tax' means the tax
25	imposed under section 121 of this title.

1	(35) 'Withholding tax' means the amount that a
2	payer is required to withhold from a payment as tax."
3	Section 4. Section 803 of chapter 8 of title 54 of the Code
4	of the Federated States of Micronesia is hereby repealed in its
5	entirety and a new section 803 inserted to read as follows:
6	"Section 803. References to terms used in other laws.
7	When this chapter applies in respect of a revenue law,
8	any term not defined in this chapter has the meaning
9	that it has for the purposes of the revenue law."
10	Section 5. Section 804 of chapter 8 of title 54 of the Code
11	of the Federated States of Micronesia is hereby repealed in its
12	entirety.
13	Section 6. Section 805 of chapter 8 of title 54 of the Code
14	of the Federated States of Micronesia, as amended by Public Laws
15	Nos. 7-41, 9-139, 10-68, 13-21, 13-60 and 15-24 is hereby
16	repealed in its entirety.
17	Section 7. Title 54 of the Code of the Federated States of
18	Micronesia is hereby amended by adding a new subchapter II to
19	chapter 8 to be entitled "Tax Returns".
20	Section 8. Title 54 of the Code of the Federated States of
21	Micronesia is hereby amended by adding a new section 811 to
22	subchapter II of chapter 8 to read as follows:
23	"Section 811. Extension of time to file a tax return.
24	(1) A taxpayer required to file a tax return may
25	apply, at any time and in writing, to the CEO for an

1 extension of time to file the return. 2 (2) The CEO may, upon satisfaction that there is 3 reasonable cause (as defined in regulations issued from time to time by the Authority), grant an application 4 under subsection (1) of this section and must serve 5 notice of the decision on the applicant. (3) An extension of time granted under this 7 section does not change the date for payment of tax due 8 9 as specified in the revenue law under which the return has been made, but shall extend the date from which 10 11 penalties shall be payable with respect to the late 12 filing of a return." Section 9. Title 54 of the Code of the Federated States of 13 14 Micronesia is hereby amended by adding a new section 812 to 15 subchapter II of chapter 8 to read as follows: "Section 812. Tax return duly made. 16 17 A tax return purporting to be filed by or on behalf of 18 a taxpayer is treated as having been filed by the 19 taxpayer or with the taxpayer's authority unless the 20 contrary is proved." Section 10. Title 54 of the Code of the Federated States of 21 22 Micronesia is hereby amended by adding a new subchapter III to 23 chapter 8 to be entitled "Tax Decisions". 24 Section 11. Title 54 of the Code of the Federated States of 25 Micronesia is hereby amended by adding a new section 821 to

1	subchapter III of chapter 8 to read as follows:
2	"Section 821. Self-assessments.
3	(1) For the purposes of this chapter:
4	(a) a self-assessment taxpayer who has filed
5	a self-assessment return is treated as having made
6	an assessment of the amount of tax payable for
7	the tax period to which the return relates
8	being that amount as set out in the return;
9	<u>and</u>
10	(b) a self-assessment return furnished by a
11	self-assessment taxpayer is treated as a notice
12	of the assessment served by the CEO on the taxpayer
13	on the date the return was filed.
14	(2) Reserved."
15	Section 12. Title 54 of the Code of the Federated States of
16	Micronesia is hereby amended by adding a new section 822 to
17	subchapter III of chapter 8 to read as follows:
18	"Section 822. Assessment of person who fails to file a
19	tax return.
20	(1) If a taxpayer liable for tax on an assessment
21	basis under a revenue law fails to file a tax return
22	for a tax period as required under the revenue law, the
23	CEO may, at any time, make an assessment of the tax
24	payable by the taxpayer.
) E	(2) The CEO must serve a tarrayer assessed under

1	subsection (1) of this section with notice of the
2	assessment as soon as is practicable after making the
3	assessment. The notice must state:
4	(a) the amount of tax payable;
5	(b) the amount of interest or penalty (if
6	any) payable in respect of the tax payable;
7	(c) the tax period in respect of which the
8	assessment relates;
9	(d) the date of issue of the notice; and
10	(e) the due date for payment of the tax
11	payable under the notice."
12	Section 13. Title 54 of the Code of the Federated States of
13	Micronesia is hereby amended by adding a new section 823 to
14	subchapter III of chapter 8 to read as follows:
15	"Section 823. Advanced tax assessments.
16	(1) The CEO may make an assessment of the tax
17	payable for the tax period and the tax is payable on
18	the date set out in the notice of assessment served on
19	the taxpayer if, in any tax period:
20	(a) a taxpayer liable for tax on an
21	assessment basis under a revenue law ceases to carry on
22	a trade, business, profession, vocation, or employment;
23	<u>or</u>
24	(b) the CEO has reasonable grounds to believe
25	that a taxpayer liable for tax on an assessment basis

1	under a revenue law may leave, or has left, the FSM
2	without filing a return as required under the revenue
3	law for the tax period.
4	(2) The CEO must serve a taxpayer assessed under
5	subsection (1) of this section with notice, in writing,
6	of the assessment as soon as is practicable after
7	making the assessment, and such notice must set out the
8	matters specified in section 822(2) of this title.
9	(3) An assessment made under subsection (1) of
10	this section can be amended under section 824 of this
11	title so that the taxpayer is assessed in respect of
12	the whole of the tax period to which the assessment
13	under subsection (1) of this section relates."
14	Section 14. Title 54 of the Code of the Federated States of
15	Micronesia is hereby amended by adding a new section 824 to
16	subchapter III of chapter 8 to read as follows:
17	"Section 824. Amendment of tax assessments.
18	(1) Subject to this section, the CEO may amend a
19	tax assessment by making such alterations or additions
20	to the assessment as the CEO considers necessary to
21	ensure that a taxpayer is liable for the correct amount
22	of tax payable in respect of the tax period to which
23	the assessment relates.
24	(2) A self-assessment taxpayer can apply to the
25	CEO within the time specified in subsection (3)(b) of

1	this section for the CEO to make an amendment in
2	accordance with subsection (1) of this section to a
3	self-assessment and the CEO shall serve the taxpayer
4	with notice of the decision on the application as soon
5	as is practicable after the making of the assessment.
6	(3) The amendment of a tax assessment under
7	subsection (1) of this section may be made:
8	(a) in the case of fraud or willful neglect,
9	within six years of the date the CEO served notice of
10	the assessment on the taxpayer or within one year after
11	the fraud or willful neglect is discovered, whichever
12	is the later; or
13	(b) in any other case, within six years of
14	the date the CEO served notice of the assessment on the
15	taxpayer.
16	(4) As soon as practicable after making an
17	amended assessment under this section, the CEO must
18	serve the taxpayer with notice of the amended
19	assessment.
20	(5) Subject to subsection (6) of this section, if
21	a notice of assessment (referred to as the 'original
22	assessment') has been amended under subsection (1) of
23	this section, the CEO may further amend the original
24	assessment within the later of:
25	(a) six years after the CEO served notice of

1	the original assessment on the taxpayer; or
2	(b) one year after the CEO served notice of
3	the amended assessment on the taxpayer.
4	(6) If subsection (5)(b) of this section applies,
5	the CEO is limited to amending the alterations and
6	additions made in the amended assessment to the
7	original assessment.
8	(7) An amended assessment is treated in all
9	respects as a tax assessment for the purposes of this
10	chapter (other than subsection (1) or (2) of this
11	section) and the revenue law under which the original
12	assessment has been made.
13	(8) The making of an amended assessment does not
14	preclude the liability for any interest and penalty in
15	relation to the tax assessed under amended assessment
16	arising from the date that tax was due under the
17	original assessment."
18	Section 15. Title 54 of the Code of the Federated States of
19	Micronesia is hereby amended by adding a new section 825 to
20	subchapter III of chapter 8 to read as follows:
21	"Section 825. Validity of tax decisions.
22	(1) The validity of a tax decision, a notice of a tax
23	decision, or any other document purporting to be made
24	or executed under a revenue law, if it is, in substance
25	and effect, in conformity with the law under which it

1	has been made, issued, or executed and the person
2	assessed, or intended to be assessed or affected by the
3	decision or document, is designated in it according to
4	common understanding:
5	(a) cannot be quashed or deemed to be void or
6	voidable for want of form; or
7	(b) is not affected by reason of any immaterial
8	mistake, defect, or omission therein.
9	(2) Reserved."
10	Section 16. Title 54 of the Code of the Federated States of
11	Micronesia is hereby amended by adding a new section 826 to
12	subchapter III of chapter 8 to read as follows:
13	"Section 826. Correctness of tax decisions.
14	(1) Except in proceedings under subchapter IV of
15	this chapter:
16	(a) no tax decision can be disputed in any
17	court or in any other proceedings on any ground
18	whatsoever;
19	(b) the production of the original notice of
20	a tax assessment or a document under the hand of the
21	CEO purporting to be a copy of a notice of such
22	assessment is conclusive evidence of the making of the
23	assessment and that the amount and particulars of the
24	assessment are correct; and
25	(c) in the case of a self-assessment

1 taxpayer, the production of the original selfassessment return or a document under the hand 2 3 of the CEO purporting to be a copy of such return is conclusive evidence of the contents of 4 5 the return. (2) A court must, in all proceedings, take 7 judicial notice of the signature of the CEO in either the original or copy of a notice of a tax 8 9 decision." Section 17. Title 54 of the Code of the Federated States of 10 11 Micronesia is hereby amended by adding a new section 827 to 12 subchapter III of chapter 8 to read as follows: 13 "Section 827. Rectification of mistakes. 14 If the CEO is satisfied that an order made or document issued by the CEO under a revenue law contains a 15 16 mistake that is apparent on the face of the record or 17 document and the mistake does not involve a dispute as 18 to the interpretation of the law or facts of the case, 19 the CEO may, for the purposes of rectifying the 20 mistake, amend the order or document any time before the expiry of six years from the date of making or 21 22 issuing the order or document." 23 Section 18. Title 54 of the Code of the Federated States of 24 Micronesia is hereby amended by adding a new subchapter IV to 25 chapter 8 to be entitled "Objections and Appeals".

1	Section 19. Title 54 of the Code of the Federated States of
2	Micronesia is hereby amended by adding a new section 831 to
3	subchapter IV of chapter 8 to read as follows:
4	"Section 831. Objection to tax decision.
5	(1) A person dissatisfied with a tax decision must
6	lodge an objection to the decision with the CEO within
7	30 days of service of the notice of the decision.
8	(2) If the CEO has amended an assessment under
9	section 824 of this title, the taxpayer has no further
10	right of objection that the taxpayer would have had if
11	the amendment had not been made, except to the extent
12	that by reason of the amendment a fresh liability is
13	imposed on the taxpayer or an existing liability is
14	increased.
15	(3) An objection must substantially comply with
16	the prescribed form and state fully and in detail the
17	grounds upon which the person objecting relies to
18	support the objection.
19	(4) A person may apply, in writing, to the CEO
20	for an extension of time to lodge an objection and the
21	CEO may, if satisfied there is reasonable cause, grant
22	an application under this section and must serve notice
23	of the decision on the applicant as soon as is
24	practicable after making the decision.
25	(5) Subject to subsection (6) of this section,

1	the CEO must consider the objection and either allow
2	the objection in whole or part, or disallow it, and the
3	CEO's decision is referred to as an 'objection
4	decision'.
5	(6) The CEO is not required to consider an
6	objection unless and until the person objecting has
7	complied with all the requirements under this chapter
8	or the revenue law to which the objection relates in
9	relation to the making of tax returns and payment of
10	tax.
11	(7) The CEO must serve notice of the objection
12	decision on the person objecting as soon as practicable
13	after making the decision."
14	Section 20. Title 54 of the Code of the Federated States of
15	Micronesia is hereby amended by adding a new section 832 to
16	subchapter IV of chapter 8 to read as follows:
17	"Section 832. <u>Judicial review</u> .
18	(1) A person dissatisfied with an objection
19	decision may institute an action for review in a court
20	of competent jurisdiction in the FSM. Such action is
21	commenced by filing a petition, within sixty days after
22	service of notice of the objection decision, setting
23	<pre>forth:</pre>
24	(a) assignments of errors alleged to have
25	been committed by the CEO in making the objection

1	decision;
2	(b) the facts relied upon to sustain such
3	assignments of errors; and
4	(c) a prayer for appropriate relief.
5	(2) The CEO is the defendant in proceedings under
6	subsection (1) of this section.
7	(3) The payment of the amount of tax in dispute,
8	in whole or part, after the filing of a petition under
9	subsection (1) of this section does not deprive the
10	court of jurisdiction.
11	(4) When the decision of the court or an appeal
12	there from becomes final, the CEO must, upon
13	presentment of a certified copy of the decree, make
14	such adjustments to comply with the decree as are
15	necessary to correct, amend, or abate the assessment,
16	and determine whether an additional amount of tax is to
17	be assessed.
18	(5) This section shall not condition or limit the
19	right of a taxpayer to seek immediate judicial review
20	of any action taken or to be taken under subchapter VI
21	of this chapter."
22	Section 21. Title 54 of the Code of the Federated States of
23	Micronesia is hereby amended by adding a new section 833 to
24	subchapter IV of chapter 8 to read as follows:
25	"Section 833. General provisions relating to

1	objections and appeals.
2	(1) In any proceeding under this chapter:
3	(a) in the case of a tax assessment, the
4	burden is on the taxpayer to prove that the assessment
5	is excessive; or
6	(b) in the case of a tax decision (other
7	than a tax assessment), the burden is on the person
8	objecting to the decision to prove that the decision
9	should not have been made or should have been made
10	differently.
11	(2) In an action for review by a court under
12	section 832 of this title, the person bringing the
13	action is limited to the grounds stated in the person's
14	objection to the CEO.
15	(3) To the extent necessary for the making of a
16	decision and when presented, the reviewing court shall
17	decide all relevant questions of law and fact,
18	interpret constitutional and statutory provisions, and
19	determine the meaning or applicability of the terms of
20	any action taken by the CEO.
21	(4) The reviewing court shall:
22	(a) compel any action of the CEO unlawfully
23	withheld or unreasonably delayed; and
24	(b) hold unlawful and set aside any actions
25	and decisions of the CEO found to be:

1	(i) arbitrary, capricious, an abuse of
2	discretion, or otherwise not in accordance with law;
3	(ii) contrary to constitutional right,
4	power, privilege, or immunity;
5	(iii) in excess of statutory
6	jurisdiction, authority, or limitations, or a denial of
7	<pre>legal rights;</pre>
8	(iv) without substantial compliance with
9	the procedures required by law; or
10	(v) unwarranted by the facts.
11	(5) Subject to subsection (6) of this section,
12	the tax due under a tax assessment is payable
13	notwithstanding that an objection has been lodged or an
14	action for judicial review under section 832 of this
15	title has been instituted by the taxpayer in respect of
16	the assessment.
17	(6) The CEO may, upon application in writing by a
18	taxpayer, agree to stay recovery of a tax in dispute
19	under a tax assessment up to a maximum of fifty percent
20	(50%) of the disputed tax, but only if the taxpayer has
21	paid the entire amount of tax due under the assessment
22	that is not in dispute."
23	Section 22. Title 54 of the Code of the Federated States of
24	Micronesia is hereby amended by adding a new subchapter V to
25	chapter 8 to be entitled "Recovery of Unpaid Tax".

1 Section 23. Title 54 of the Code of the Federated States of Micronesia is hereby amended by adding a new section 841 to 2 3 subchapter V of chapter 8 to read as follows: "Section 841. Payment of tax. 4 (1) A taxpayer must pay tax in the prescribed 5 manner. 7 (2) Any unpaid tax may be sued for and recovered in any court of competent jurisdiction by the CEO suing 9 in his or her official capacity as collection agent for the National or State Governments, as the case may be. 10 (3) In any suit under subsection (2) of this 11 12 section, the production of a certificate signed by the 13 CEO stating the name and address of the taxpayer and 14 the amount of tax due is sufficient evidence that the 15 amount of tax is due by the taxpayer and sufficient authority for the court to give judgment with full 16 17 costs of suit against the taxpayer." Section 24. Title 54 of the Code of the Federated States Of 18 19 Micronesia is hereby amended by adding a new section 842 to 20 subchapter V of chapter 8 to read as follows: 21 "Section 842. Extension of time to pay tax. 22 (1) A taxpayer may apply, in writing, to the CEO 23 for an extension of time to pay tax due under a revenue 24 law. 25 (2) If an application has been made under this

1	section, the CEO may, having regard to the
2	circumstances of the case:
3	(a) grant the taxpayer an extension of time
4	for payment of the tax due; or
5	(b) require the taxpayer to pay the tax due
6	in such installments as the CEO may determine, and the
7	CEO must serve the taxpayer with written notice of the
8	decision.
9	(3) If a taxpayer permitted to pay tax by
10	installments defaults in the payment of an installment,
11	the whole balance of the tax outstanding, at the time
12	of default, is immediately payable.
13	(4) The grant of an extension of time or
14	permission to pay tax due by installments does not
15	preclude the liability for late payment interest
16	arising from the original date the tax was due for
17	payment."
18	Section 25. Title 54 of the Code of the Federated States of
19	Micronesia is hereby amended by adding a new section 843 to
20	subchapter V of chapter 8 to read as follows:
21	"Section 843. Trustees, liquidators, and executors.
22	(1) In this section:
23	(a) "trustee" means:
24	(i) a liquidator of a company being
25	wound up;

1	(ii) a receiver for debenture holders
2	who has taken possession of any assets of a company;

13	(2) A trustee must, within 14 days after becoming
14	a trustee in respect of, or assuming the control of
15	assets of a taxpayer in the capacity as trustee, give
16	written notice thereof to the CEO.
17	(3) The CEO must notify the trustee, in writing,
18	of the amount of any tax that is payable by the
19	taxpayer and such notice must be served on the trustee
20	within one month of the CEO being served with a notice
21	under subsection (2) of this section.
22	(4) Subject to subsection (5) of this section, a
23	trustee:
24	(a) must not, without the leave of
25	the CEO, dispose of any asset of the taxpayer until a

1	notice has been served on the trustee under subsection
2	(3) of this section;
3	(b) must set aside, out of the assets
4	available for the payment of tax due by the taxpayer,
5	assets to the value of the amount notified under
6	subsection (3) of this section, or the whole of the
7	assets if their value is less than the amount notified;
8	<u>and</u>
9	(c) is, to the extent of the value of the
10	assets required to be set aside, liable for the tax due
11	by the taxpayer.
12	(5) A trustee may pay the expenses properly
13	incurred by the trustee in the capacity as such,
14	including the trustee's remuneration, in priority to
15	the amount notified under subsection (3) of this
16	section.
17	(6) If two or more persons are trustees in
18	respect of a taxpayer, the obligations and liabilities
19	under this section apply jointly and severally to the
20	trustees but may be discharged by any of them.
21	(7) The amount that a trustee is liable for under
22	subsection (4)(c) of this section is treated as if it
23	were tax payable by the trustee as taxpayer for the
24	purposes of this subchapter, subchapter VI of this
25	chapter, and section 871 of this title."

17	to comply with a notice under this section is
18	personally liable for the amount specified in the

20	(14) The amounts referred to in subsections (10)
21	and (13) of this section are treated as if they were
22	tax payable by the payer as taxpayer for the purposes
23	of this subchapter, subchapter VI of this chapter, and
24	section 871 of this title."
25	Section 27 Title 54 of the Code of the Federated States of

Micronesia is hereby amended by adding a new section 845 to 1 subchapter V of chapter 8 to read as follows: 2 "Section 845. 5	seized goods is treated as if they were tax payable by
6	the person whose goods have been seized as taxpayer for
7	the purposes of this subchapter and section 871 of this

9	Section 28. Title 54 of the Code of the Federated States of
10	Micronesia is hereby amended by adding a new section 846 to
11	subchapter V of chapter 8 to read as follows:
12	"Section 846. CEO may require security.
13	The CEO may, for the purposes of securing payment of
14	any tax that is or will become due, require a taxpayer
15	to give security in such amount and in such manner as
16	the CEO thinks fit."
17	Section 29. Title 54 of the Code of the Federated States of
18	Micronesia is hereby amended by adding a new section 847 to
19	subchapter V of chapter 8 to read as follows:
20	"Section 847. Taxpayer leaving the FSM.
21	(1) If the CEO has reasonable grounds to believe

2	(5) If the tax due is paid in full within the
3	period of closure, or a satisfactory arrangement is
4	reached with the CEO with respect to payment of the
5	tax, the order issued under subsection (2) of this
6	section ceases to have effect and the CEO must
7	immediately arrange for removal of the notice referred
8	to in subsection (4) of this section."
9	Section 31. Title 54 of the Code of the Federated States of
10	Micronesia is herby further amended by adding a new subchapter VI
11	to chapter 8 to be entitled "Levy and Execution".
12	Section 32. Title 54 of the Code of the Federated States of
13	Micronesia is hereby amended by adding a new section 851 to
14	subchapter VI of chapter 8 to read as follows:
15	"Section 851. Tax as lien on property.
16	(1) If any taxpayer neglects or refuses to pay,
17	or withhold and pay, or collect and pay any tax that is

23	willful failure by any person upon whom it is served to
24	comply with its terms.

1	been made by virtue of a tax warrant is not sufficient
2	to satisfy the claim for which levy is made, the CEO,
3	thereafter, and as often as may be necessary, may
4	proceed to levy in like manner upon any other property
5	of the taxpayer against whom the claim exists, until
6	the amount due from the taxpayer is fully paid.
7	Section 34. Title 54 of the Code of the Federated States of
8	Micronesia is hereby amended by adding a new section 853 to
9	subchapter VI of chapter 8 to read as follows:
10	"Section 853. Surrender of property subject to levy;
11	penalty and notice.
12	(1) Upon receipt of a tax warrant issued pursuant
13	to section 852 of this title, any person in possession
14	or control of property subject to levy under a tax
15	warrant shall immediately surrender the property or
16	discharge the obligation to the CEO; PROVIDED, HOWEVER,

9	signing of an agreement with the Authority."
10	Section 36. Title 54 of the Code of the Federated States of
11	Micronesia is hereby amended by adding a new section 855 to
12	subchapter VI of chapter 8 to read as follows:
13	"Section 855. Sale; delivery of bill of sale;
14	disposition of unsold portion.
15	(1) Except as provided in subsection (4) of this
16	section, the Authority shall sell the property,
17	excluding cash and liquid deposits, at a public auction
18	and in accordance with the notice of sale, and shall
19	deliver to the purchaser a bill of sale for the
20	property sold.

22	section, payment must be in full, in cash or its
23	equivalent, and made immediately after the acceptance

25	(3) The unsold portion of any property seized may

1	be left at the place of sale at the risk and cost of

11	sooner than the date scheduled for the sale as stated

15	made to a revenue officer means a statement made in
16	writing or orally to a revenue officer acting in the
17	performance of the officer's duties under a revenue
18	law, and includes a statement made:
19	(a) in any application, certificate,
20	declaration, notification, tax return, objection, or
21	other document furnished or lodged under a revenue law;
22	(b) in any information required to be
23	furnished under a revenue law;
24	(c) in any document furnished to a revenue
25	officer:

1	(d) in answer to a question asked of a
2	person by a revenue officer; or
3	(e) to another person with the knowledge or
4	reasonable expectation that the statement would be
5	passed on to a revenue officer."
6	Section 64. Title 54 of the Code of the Federated States of
7	Micronesia is hereby amended by adding a new section 896 to
8	subchapter X of chapter 8 to read as follows:
9	"Section 896. Collection of penalty.
10	(1) A liability for penalty is calculated
11	separately with respect to each section imposing a
