A BILL FOR AN ACT

To further amend section 221 of title 54 of the Code of the Federated States of Micronesia, as amended by Public Law No. 13-60, to increase the import duty on bottled water to 150 percent, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 221 of title 54 of the Code of
- 2 the Federated States of Micronesia, as amended by Public
- 3 Law No. 13-60, is hereby further amended to read as
- 4 follows:
- 5 "Section 221. Levy and rates.
- 6 The following import duties are hereby levied on all
- 7 products specified herein which are imported into the
- 8 FSM:
- 9 (1) cigarettes, at the rate of \$0.025 per
- 10 cigarette, provided that this rate shall increase by
- 11 \$0.005 per cigarette on January 1 of each of the
- 12 years 2007, 2009, 2011, 2013 and 2015;
- 13 (2) tobacco, other than cigarettes, at the rate of
- 14 fifty percent ad valorem;
- 15 (3) perfumery, cosmetics, and toiletries,
- 16 including cologne and other toilet waters, articles
- of perfumery, whether in sachets or otherwise, and
- 18 all preparations used as applications to the hair or
- skin, lipsticks, pomades, powders, and other toilet

1	preparations not having medicinal properties, at the
2	rate of twenty five percent ad valorem;
3	(4) soft drinks, drink mixes, drink preparations,
4	coffee, tea, and nonalcoholic beverages other than
5	bottled water, at the rate of twenty five percent ad
6	valorem, provided, however, that any beverage having
7	a fruit juice content of twenty five percent or more
8	by volume shall be at the rate of three percent ad
9	valorem;
10	(5) bottled water, at the rate of one hundred and
11	fifty percent ad valorem;
12	$\left[\frac{5}{6}\right]\left(\frac{6}{6}\right)$ beer and malt beverages, at the rate of \$0.25
13	per 12 fluid ounces;
14	$\left[\frac{6}{2}\right]\left(\frac{7}{2}\right)$ distilled alcoholic beverages, at the rate of
15	twelve dollars per gallon;
16	[7] (8) wine at the rate of thirty percent ad
17	valorem;
18	$[8](\underline{9})$ foodstuffs for human consumption, at the rate
19	of three percent ad valorem; provided, however, that
20	fresh and frozen fish and seafood, shall be at the
21	rate of twenty five percent ad valorem;
22	[9] (10) gasoline and diesel fuel, at the rate of five
23	cents per gallon;
24	$\left[\frac{10}{11}\right]$ ($\frac{11}{11}$) laundry bar soap, at the rate of twenty five
25	percent ad valorem; and
