A BILL FOR AN ACT

To appropriate the sum of \$2,800,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2012, for the purpose of funding public projects and social programs in the States of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$2,800,000, or so much thereof as 2 may be necessary, is hereby appropriated from the General Fund 3 of the Federated States of Micronesia for the fiscal year 4 ending September 30, 2012, for the purpose of funding public 5 projects and social programs in the States of Yap, Kosrae, 6 Pohnpei and Chuuk. The funds appropriated under this section 7 shall be apportioned as follows:

8 Section 2. Of the sum of \$2,800,000 appropriated by this 9 act, \$400,000 is apportioned for Yap State for public projects 10 and social programs.

18 Section 7. This act shall become law upon approval by the 19 President of the Federated States of Micronesia or upon its 20 becoming law without such approval.
