A BILL FOR AN ACT

To further amend section 6 of Public Law No. 16-49, as amended by Public Laws Nos. 17-10 and 17-45, by changing the allottee of certain funds previously appropriated therein for the purpose of funding public projects and social programs in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 6 of Public Law No. 16-49, as amended
- 2 by Public Laws Nos. 17-10 and 17-45, is hereby amended to read
- 3 as follows:

"Section 6. Allotment and management of funds and lapse 4 date. All funds appropriated by this act shall be 5 allotted, managed, administered and accounted for in 6 7 accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. allottee shall be responsible for ensuring that these 10 funds, or so much thereof as may be necessary, are used 11 solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum 12 13 appropriated. The allottee of funds appropriated under 14 sections 2 and 4 of this act shall be the President of the Federated States of Micronesia or his designee; 15 16 PROVIDED THAT the allottee of funds appropriated under 17 section 4(1)(b) shall be the Pohnpei Transportation 18 Authority and the allottee of the funds appropriated

1	under section 4(1)(j) shall be the Mayor of Kolonia Town
2	Government. The allottee of funds appropriated under
3	section 3 of this act shall be the Governor of Yap State.
4	The allottee of funds appropriated under [subsections
5	5(1)(4)(5)(6), (7) and (8) of this act shall be the Chuuk
6	State Commission on Improvement Project (CSCIP)
7	subsections 5(1) and 5(7) of this act shall be the
8	Governor of Chuuk State or his designee. The allottee of
9	funds appropriated under subsection 5(2) of this act
10	shall be the Mortlock Islands Development Authority
11	(MIDA). The allottee of funds appropriated under
12	subsection 5(3) of this act shall be the Executive
13	Director of the Northern Namoneas Social and Economic
14	Development Authority. The allottee of funds appropriated
15	under subsection 5(4) of this act shall be the Southern
16	Namoneas Development Authority. The allottee of funds
17	appropriated under subsection 5(5) of this act shall be
18	the Faichuk Development Authority. The allottee of funds
19	appropriated under subsection 5(6) of this act shall be
20	the Northwest Development Authority. The funds
21	appropriated by this act shall lapse on September 30,
22	2014."
