A BILL FOR AN ACT

To appropriate the sum of \$2,100,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2012, for the purpose of funding public projects and social programs in the States of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. The sum of \$2,100,000, or so much thereof as 2 may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year 3 ending September 30, 2012, for the purpose of funding public 4 projects and social programs in the States of Yap, Kosrae, 5 Pohnpei and Chuuk. The funds appropriated under this section 6 shall be apportioned as follows: 7 Section 2. 25	necessary, are used solely for the purpose specified in this

2	appropriated. The allottee of the funds appropriated under
3	sections 2 through 5 of this act shall be the President of the
4	Federated States of Micronesia. The authority of the allottee
5	to obligate funds appropriated by this act shall lapse on
6	September 30, 2014.
7	Section 7. This act shall become law upon approval by the
8	President of the Federated States of Micronesia or upon its
9	becoming law without such approval.
