A BILL FOR AN ACT

To further amend Public Law No. 16-62, as amended by Public Laws Nos. 16-71, 17-05 and 17-18, by amending section 4 thereof, to change the use of certain funds previously appropriated therein to fund public projects and social programs in the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
