
I am pleased to inform you that I have designated the following Congressional Act No. 17-48 as Public Law No. 17-49:

Congressional Act No. 17-48, "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 17-19, AS AMENDED BY PUBLIC LAWS. NOS. 17-28 AND 17-31, BY AMENDING SECTION 3 THEREOF, TO CHANGE THE USE OF FUNDS PREVIOUSLY APPROPRIATED FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2012, AND FOR OTHER PURPOSES."

As set forth in this Act, its purpose is to change the use of funds previously appropriated, by decreasing the amount appropriated for Personnel of the Congress Staff by \$20,000 and adding this amount to each Congressional Delegation Office under Contractual Services.

In passing this law, I reiterate the executive branch's commitment in working with the legislative branch to accomplish all the goals set forth in the interest and well being of our citizens.

CONGRESSIONAL BILL NO. 17-122

PUBLIC LAW NO. 17-49

AN ACT

To further amend Public Law No. 17-19, as amended by Public Laws Nos. 17-28 and 17-31, by amending section 3 thereof, to change the use of funds previously appropriated for the fiscal year ending September 30, 2012, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 17-19, as amended
2 by Public Laws Nos. 17-28 and 17-31, is hereby amended to read
3 as follows:

4 "Section 3. Operating Expenses of the Legislative
5 Branch. The sum of \$3,325,228, or so much thereof
6 as may be necessary, is hereby appropriated from the
7 General Fund of the Federated States of Micronesia
8 for the fiscal year ending September 30, 2012, for
9 the operations of the Legislative Branch of the
10 National Government during fiscal year 2012. The
11 sum appropriated by this section shall be
12 apportioned as follows:

13 (1) Speaker and Members.

14 The sum of \$1,490,771, or so much thereof as may be
15 necessary, for the operations of the Office of the
16 Speaker and Members of the Congress of the Federated
17 States of Micronesia during fiscal year 2012. The
18 sum appropriated herein shall be apportioned as
19 follows:

7 The sum of \$1,324,457, or so much thereof as may be
8 necessary, for the operations of the Congress staff
9 offices during fiscal year 2012. The sum
10 appropriated herein shall be apportioned as follows:

13	Contractual Services	210,500
14	OCE.....	127,000
15	Fixed Assets	34,000

16 (3) Congress Delegation Offices.

17 The sum of \$510,000, or so much thereof as may be
18 necessary, for the operations of the Congress
19 delegation offices during fiscal year 2012. Of the
20 amounts appropriated for contractual services within
21 each Delegation Office, up to a maximum of \$25,000
22 per Member, at the Delegation Offices' discretion,
23 may be used for Member Representation. The sum
24 appropriated is apportioned as follows:
