

AN ACT

To further amend Public Law No. 16-58, as amended, by amending Section 5 thereof, to change the use of certain funds previously appropriated for the purpose of funding public projects and social programs for fiscal year 2011 in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 16-58 is hereby
