PUBLIC LAW No. 17- 82

AN ACT

To further amend sections 3 and 4 of Public Law No. 16-49, as amended by Public Laws Nos. 16-68, 16-76 and 17-06, to modify the use of certain funds previously appropriated to fund public projects and social programs in the States of Yap and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 16-49, as amended
2 by Public Laws Nos. 16-68 and 17-76, is hereby further amended
3 to read as follows:
