#### PUBLIC LAW NO. 17-42

#### AN ACT

To further amend section 1 of Public Law No. 13-36, as amended by Public Laws No. 13-49, to change the use of certain funds previously appropriated therein, and for other purposes. BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 1. Section 1 of Public Law No. 13-36, as amended by 1 Public Law No. 13-49, is hereby further amended to read as 2 3 follows: "Section 1. The sum of \$400,000, or so much thereof as 4 5 may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for 6 the fiscal year ending September 30, 2004, to provide 7 funding for social and economic development projects in 8 the State of Kosrae. The funds appropriated under this 9 section shall be apportioned as follows: 10 (1) KUA-Power extension to Walung .....\$ 90,000 11 (2) Kosrae Visitors Bureau ..... 12 7,000 (3) DOE-classroom construction and furniture 13 50,000 (4) Health Services Department-Pharmaceuticals 14 15 and medical equipment ..... 50,000 16 (5) Utwe/Walung Marine Park-Renovation ... 6,500 (6) Division of Women-Women's Center extension 17 8,500 (7) Kosrae Red Cross Chapter-operations ... 18 6,000 (8) DC&I-Consultant fee for self-help housing 19
