AN ACT

To further amend Public Law No. 17-19, as amended by Public Laws Nos. 17-28 and 17-31, by amending section 3 thereof, to change the use of funds previously appropriated for the fiscal year ending September 30, 2012, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
