## AN ACT

To further amend sections 2 and 3 of Public Law No. 14-107, as amended by Public Laws Nos. 15-03, 15-20, 17-15, and 17-43, to change the use and designate allottee of certain funds previously appropriated for Yap State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 2 of Public Law No. 14-107, as amended
2	by Public Laws Nos. 15-03, 15-20, 17-15, and 17-43 is hereby
3	further amended to read as follows:
4	"Section 2. The sum of \$421,100, is hereby
5	appropriated from the General Fund of the Federated
6	States of Micronesia for the fiscal year ending
7	September 30, 2007 for the purpose of funding public
8	projects and social programs in the States of Chuuk,
9	Kosrae, Pohnpei and Yap. The funds appropriated
10	under section 1 of this act shall be apportioned as
11	follows:

7		limited to, the Financial Management Act of 1979.
8		The allottee of the funds appropriated in subsection
9		1 (a) and (c) of Section 1 of this Act shall be the
10		Governor of Yap State. The allottee of funds
11		appropriated in subsection 1 (b) of section 1 of this
12		Act shall be the President of the College of
13		Micronesia - FSM. The allottee of the funds
14		appropriated in subsection 2 of Section 1 of this Act
15		shall be the Chuuk State Commission on Improvement
16		Project (CSCIP). The allottee of funds appropriated
17		in subsections 3 and 4 of Section 1 of this Act shall
18		be the President of the Federated States of
19		Micronesia or his designee. The allottee shall be
20		responsible for ensuring that these funds, or so much
21		thereof as may be necessary, are used solely for the
22		purpose specified in this act, and that no
23		obligations are incurred in excess of the sum
24		appropriated. The authority of the allottee to
25		obligate funds appropriated by this act shall not
