PUBLIC LAW NO. 17-85

AN ACT

To further amend section 6 of Public Law No. 16-49, as amended by Public Laws Nos. 17-10 and 17-45, by changing the allottee of certain funds previously appropriated therein for the purpose of funding public projects and social programs in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 6 of Public Law No. 16-49, as amended
by Public Laws Nos. 17-10 and 17-45, is hereby amended to read
as follows:

"Section 6. Allotment and management of funds and lapse 4 date. All funds appropriated by this act shall be 5 allotted, managed, administered and accounted for in 6 7 accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. 8 The 9 allottee shall be responsible for ensuring that these 10 funds, or so much thereof as may be necessary, are used 11 solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum 12 13 appropriated. The allottee of funds appropriated under 14 sections 2 and 4 of this act shall be the President of the Federated States of Micronesia or his designee; 15 16 PROVIDED THAT the allottee of funds appropriated under 17 section 4(1)(b) shall be the Pohnpei Transportation 18 Authority and the allottee of the funds appropriated

1	under section 4(1)(j) shall be the Mayor of Kolonia Town
2	Government. The allottee of funds appropriated under
3	section 3 of this act shall be the Governor of Yap State.
4	The allottee of funds appropriated under subsections 5(1)
5	and 5(7) of this act shall be the Governor of Chuuk State
6	or his designee. The allottee of funds appropriated
7	under subsection 5(2) of this act shall be the Mortlock
8	Islands Development Authority (MIDA). The allottee of
9	funds appropriated under subsection 5(3) of this act
10	shall be the Executive Director of the Northern Namoneas
11	Social and Economic Development Authority. The allottee
12	of funds appropriated under subsection 5(4) of this act
13	shall be the Southern Namoneas Development Authority. The
14	allottee of funds appropriated under subsection 5(5) of
15	this act shall be the Faichuk Development Authority. The
16	allottee of funds appropriated under subsection 5(6) of
17	this act shall be the Northwest Development Authority.
18	The funds appropriated by this act shall lapse on
19	September 30, 2014."
