Dear Mr. Speaker:

Your Committee on Ways and Means, to which was referred Presidential Communication No. 18-167 and Congressional Bill No. 18-98, C.D.10, regarding the veto of Congressional Act No. 18-34, begs leave to report as follows:

Congressional Act No. 18-34 was vetoed by the President and did not become Public Law. The Congressional Act was then referred back to your Committee on Ways and Means.

Presidential Communication No. 18-167 echoes the usual Executive objections to Congressional procedure on public projects and specifically recommended that Congress prioritize projects such as "Fly Micronesia" and the Set Aside fund over additional public project spending. Yet, the decision of which projects to prioritize is a policy decision, and Presidential Communication No. 18-167 failed to provide a specific objection to any particular project. Nor did it maintain that inadequate funds existed for the given projects. Presidential Communication No. 18-167 further did not recognize that C.B. No. 18-98 reached a C.D.10, demonstrating it was the product of careful thought, debate, deliberation, and work by Congress in reaching its final submitted form as Congressional Act 18-34.

Your Committee thus views the veto as solely the result of a policy decision by the Executive. Your Committee has revisited the items
