Culture and Historic Preservation Office, the Department of Justice and the Department of Finance and Administration.

Representatives from the Department of Health and Social Affairs confirmed for the Committee that the funding was to assist in the continuation of the highly successful program of immunizing and vaccinating our Nation's children. This funding would be for this calendar year of 2014. There is currently approximately an 80% total coverage rate for this program. It is well known to the Committee that while this program has reached almost all of its target population on the main islands, the immunization and vaccination rates for children on the outer islands is much lower. It is envisioned that through upgraded modification of the system in each of the States the program would be able to run immunization coverage on a regular, periodic basis.

This grant funding will also continue its outreach activities to smaller dispensaries which have enormous challenges due to unavailability of essential drugs and trained health care staff. The National immunization program continues to work with each of the States in training staff on program management, vaccines and cold chain management, and injection safety. In the case of Chuuk the immunization program has established a boat rental contract service to conduct outreach in the lagoon islands. Trips to the outer islands of Yap to conduct immunizations are scheduled to happen 2-4 times during the year, depending on funding.

As request the Department of Health and Social Affairs provided the following detailed budget for the program funded by this grant award, and it follows below.
