Representatives from the Department of Health and Social Affairs confirmed for the Committee that the funding was to assist building a successful program of abstinence education for our Nation's youth. This funding would be for this calendar year of 2014. This program is still working on assessment and program building but the Committee did hear of the hard work already done by the Department in this area.

The Department was also able to provide a budget for the program as follows: \$10,000 for in country travel, \$5,492 for supplies and \$32,000 in contractual services. No money from this grant will be used on personnel, and it was confirmed with the Department that the grant money would be divided evenly between the States.

Your Committee agrees that continued funding for abstinence education is very important for the Federated States of Micronesia. Your Committee on Health and Social Affairs is in accord with the intent and purposes of C.R. No. 18-131, and recommends its adoption in the form attached hereto.
