Your Committee on Ways & Means, to which was referred Presidential Communication 18-303 and Congressional Bill 18-170, C.D.1, regarding the veto of Congressional Act 18-76, entitled:

"A BILL FOR AN ACT TO APPROPRIATE THE SUM OF \$5,100,000 FROM THE GENERAL FUND OF THE FEDERATED STATES OF MICRONESIA FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2014, FOR THE PURPOSE OF FUNDING PUBLIC PROJECTS AND SOCIAL PROGRAMS IN THE STATES OF YAP, KOSRAE, POHNPEI AND CHUUK, AND FOR OTHER PURPOSES.",

begs leave to report as follows:

The intent and purpose of this act is expressed in its title.

Congressional Act 18-76 was line item vetoed by the President becoming Public Law No. 18-70. The Congressional Act was then referred back to your Committee on Ways and Means. Your Committee notes that P.C. 18-303 does not cite a lack of funding, an issue with the drafting of the bill, nor did it raise an issue of legal/constitutional objections.

Your Committee on Ways and Means has reviewed P.C. 18-303 and concluded that the reasons for the line item veto are
