Your Committee held a joint public hearing with the Committee on External Affairs on July 10, 2014. In attendance were the Acting Director of National Archives, Culture and Historic Preservation Office and his key staff, the Department of Justice and the Department of Finance and Administration.

The Acting Director stated that up to \$35,000 was available under this grant and that he evaluated proposals from the States to utilize money under this grant, no funding is used at the National level. Unfortunately, this year only the library in Pohnpei applied for this grant. He encouraged the libraries in all the States to apply next year as the several projects could be supported with the maximum funding.

Your Committee again expressed its appreciation of the efforts made by the Office agrees that funding for our libraries is very important for the Federated States of Micronesia. Your Committee on Health and Social Affairs is in accord with the intent and purposes of C.R. No. 18-185, and recommends its adoption in the form attached hereto.
