citizens. Continued financial support for this program is desirable.

The Secretary of the Department of Health and Social Affairs and her relevant staff gave a brief summary of the state of this program. It is noted that additional funding is also proposed for this program by the same donor in the amount of \$22,716 in companion funding in C.R. No. 18-199.

The program supported by this funding provides for the epidemiologist for the Nation. This professional is based in Pohnpei, but travels regularly through all the States. It also provides funding for each of the State laboratories, and the equipment and supplies for those facilities. This program has not suffered the funding cuts that other programs have as international organizations such as the U.S. Centers for Disease Control and Prevention place a high value on the surveillance and public health missions.

A brief one page budget regarding this grant funding was submitted to your committee. The budget rests at the National level, however, the services of the epidemiologist, equipment and supplies are apportioned out to the States. The breakdown for the budget is as follows: Personnel: \$33,797; Equipment: \$15,697; Supplies: \$9,968; Travel: \$5,285; Contractual: \$7,849; and Other Costs: \$10,282.

Overall your Committee on Health and Social Affairs is supportive of the program that this grant will support. Your Committee on Health and Social Affairs is in accord with the intent and purposes of C.R. No. 18-198, and recommends its adoption in the form attached hereto.
