mental illness are many. Your committee believes this grant will have a positive impact on the health of our Nation's citizens and that financial support for this new program is desirable.

The Secretary of the Department of Health and Social Affairs and her relevant staff gave a brief summary of this program. It is noted that funding will remain at the National level, but in the initial year the project will be launched in Pohnpei State . In the attached budget the summary provides the cost of supplies and services to be used. The budget for this grant is attached.

Your committee has been briefed over the years regarding the disproportionate rates of mental illness in our youth. Some types of mental health problems, such as depression, can be directly related to unemployment and lack of access to meaningful occupation of their time. The project as proposed intends to integrate with other departments and agencies to better serve our young people. Your committee was impressed with this new program, particularly since it will provide additional services to our youth.
