Otto, and members Joseph J. Urusemal, Florencio S. Harper and Yosiwo P. George.

At the hearing, your Committee was informed that the nominee will

replace Charles Cheng as the representative of Yap State on the Social Security Board. The nominee's bio data is attached with this report as part of the report.

The nominee was given a chance to express his views on the nomination. He thanked the Committee for the opportunity and indicated that if he is confirmed, he is ready to assist the Program. He commented that while working together, the Board could successfully accomplish the Program's goals. Senator Joseph J. Urusemal welcomed the nominee, and had no questions regarding the qualifications of the nominee to serve on the Social Security Board. He further asked whether the nominee sits on any Board. The nominee indicated that he has served on several Boards in the State of Yap, for instance, the Board of YCAP, the Board of Education, the Board of Diving Seagull, and the Yap Development Center Advisory Board.

The Administrator of the Program, Mr. Alex Naruhn informed the Committee that currently the Board cannot transact any business because there is no quorum. Consequently, most of the appeal cases are on hold. He then requested the Committee to expedite the action of this resolution so that the Board can start reviewing these pending appeal cases. Mr. Narruhn commented that with the nominee's background on investment, he will be an asset to the Program. He also stated that he fully supports the nomination.

Mr. Petrus commented that the President trusts the Committee's wisdom in its deliberation on the nomination. He stated that the Governor of Yap State transmitted two names, and President had chosen to transmit the nominee's name. The Administrator, Mr. Narruhn had advised the President to select the nominee because he will have no problem working with him. The Administrator also pointed out the he knew the nominee at Xavier High School.

Your Committee inquired whether the nominee will have conflicting schedules if he is confirmed to be a member of the Social Security Board because he sits on several Boards in Yap State. The nominee indicated that he sees it as complimentary when he attends Board meeting outside of Yap State.
