The nominee is well known to the Committee and has held several government positions in public health over the last twenty years. He is also a prior board member of MiCare. The Administrator stated that the nominee's experience and dedication make him an excellent choice for membership on the MiCare Board of Directors at this time. The Administrator noted that the nominee has a public health and medical background, as well as, knowledge regarding the financial aspects of healthcare and management systems.
