of Justice. The Department of Health and Social Affairs stated that this grant supplements a larger grant for emergency preparedness, and was very important to ensure that the proper equipment and training was available to handle pediatric cases. Cases were cited where lack of equipment for the treatment of children has resulted in tragic outcomes.

The one page budget summary attached to this report was submitted by the Department to the Committee during the hearing. The proposed grant is a threefold increase in funding over last year. Included in this budget is funding for personnel and training. The Department stated that training was important as equipment in past years was not utilized due to a lack of training.

Your Committee was troubled by the budget as presented as a large portion still rests with the National Department of Health and Social Affairs. The Department stated that training and travel rested with it as they were in the best position to target where training was needed and provide that. It also stated that in the past the State Government's did not file the necessary vouchers and paperwork after travel so some funding had been lost. The Committee stated that the States and individuals needed to adhere to the guidelines and should be responsible for these aspects of the grant.

Your Committee would like to offer the following amendment to C.R. No. 18-264, to read as follows:

1. Page 1, line 13, delete "Sixth Special Session" and insert "Seventh Special Session" in lieu thereof.
