Your Committee on Judiciary and Governmental Operations, to which was jointly referred Presidential Communication No. 17-379, begs leave to report as follows:

Your Committee conducted a series of public hearings following the convening of the First Regular Session of the Eighteenth Congress on May 11, 2013. The report and recommendations that follow are based upon the information contained in the Budget Book and the input provided by witnesses at those hearings.

Your Committee's findings and recommendations follow:

### DISCUSSION OF FY 2014 BUDGET

The appropriations discussed below are presented, by department, office and agency, in the order in which they appear in the Budget Book. The figures given for each department, office and agency include the figures from the budget book for the total amount appropriated by law for FY 2013, as set forth in Public Law No. 17-64, as amended, and the amount recommended by EBRC for each entity for FY 2014.

Your Committee is supporting the Department's plan to have the three patrol boats and FSS Unity fully staffed to gather a year's data on the revenue effects. Your Committee also encourages the National Police to demonstrate diversity in recruiting from the four states when filling these fourteen additional positions.

Your Committee notes that the Office of the Public Defender's request to EBRC was only slightly higher than FY2013, but omitted certain items as covered below.

Personnel - Your Committee finds the need to eliminate four Public Defender Representative positions to be replaced with four Staff Attorney positions. Your Committee finds a need for two full-fledged attorneys at a minimum at each of the four offices. Further, some attorneys are currently working at a lower rate of pay as Representatives, though they should be at attorney salary. Your Committee hopes to incentivize those receiving a law degree to stay in the FSM and finds this change comports with that goal. Given the importance of these positions, your Committee recommends the requirement that unfilled positions are closed after six months be vacated in this instance.

**Travel -** Your Committee notes a decrease in the Travel line compared with FY2013, and approves the EBRC recommendation.

Contractual Services - Your Committee notes a decrease in the Contractual Services line compared with FY2013. Yet, this decrease came at the sacrifice of the Annual Conference, which your Committee finds important. Readjusting to include the Annual Conference still places this line below FY2013.

Personnel - Your Committee notes the request made for two additional bailiff positions at \$11,000 per year. Considering the importance of additional security and that the proposed budget in total is below FY2013, your Committee recommends these positions be created. There was also a slight discrepancy in one individual's salary, which was corrected. Your Committee also takes notice of the fact that salaries for Justices are the lowest in the region and recommends the issue of increasing judicial salaries be revisited.

The Committee notes that in spite of FY 2014 being an off year for elections, the National Election Commission Office continues throughout the year to register citizens for Voter ID Cards, field election law questions, and prepare for the next election.

**Personnel -** The increase in the EBRC-recommended Personnel line is due to a request for another clerk in Chuuk. Currently, only one clerk handles the entire state of Chuuk, thus your Committee approves the request for an additional clerk.

Travel - The increase in the Travel line is due to fare increases. At hearing, the Office requested an increase, but less than the EBRC's. Thus, your Committee approves the request from the Election Office.

Contractual Services - The increase in the Contractual Services line is due to an increase in the cost to lease office space in Chuuk, and a voter ID maintenance contract costing \$28,000. Your Committee approves the EBRC recommendation.

Other Current Expenses - Your Committee notes the EBRC increase in OCE from FY2013 is largely due to the \$10,000 request for a website to answer questions regarding election law and approves the EBRC recommendation. Rather than funding individual websites for each office, your Committee recommends the exploration of a master website which various departments could share.

Your Committee also notes that some states have not complied with the requirement to report on their use of these funds. While approving these funds in the FY2014 budget, your Committee will be watching how these funds are used in this budget cycle to determine the status of these subsidies going forward.

Your Committee notes that Trafficking in Persons is an abhorrent crime and FSM narrowly averted being placed as a Tier 3 country, which would have had drastic negative impacts on receivable aid. Therefore, while the Secretary of the Department of Justice has assured that aid is being sought from foreign governments and NGOs, your Committee wishes to send a message of support by providing funding from domestic revenue to combat this repugnant practice.

Your Committee approves the amount recommended by EBRC, noting that keeping three vessels at sea for 225 days per year costs approximately \$1.5 million dollars.

Your Committee invited each of the state's judiciaries to submit reports relating to these subsidies and only two states complied. Although your Committee is increasing funding this budget cycle, states should not and cannot rely on the National Government to cover the expenses of state judiciaries in the face of the decrement. Furthermore, your Committee is entirely in accord with seeing time standards implemented for case completion at the national and state courthouses. Data from the IFC and other sources show that case completion times are the longest in the region and have a significant negative impact on the FSM's rating as a business-friendly environment. Thus, your Committee encourages prompt action from state judiciaries in implementing time standards for case completion, which can be considered at the next budget cycle.

The FSM contribution to the MLSC is used to subsidize the salaries of staff in its four offices in the FSM, and to defray part of the \$1.274 million cost to provide services in the FSM. Although our contribution has remained level for the past several years, the Director informed your Committee there has been a decrease in external funding which would result in layoffs if the allocation were not increased. \$278,000 is the amount needed, according to the MLSC, to prevent this from occurring. Therefore, your Committee recommends \$250,000 be allocated to MLSC with the remaining \$28,000 to be covered by the states. Since the states benefit greatly from the presence of MLSC, they should share in the support of this institution.
