## A BILL FOR AN ACT

To appropriate the sum of \$1,200,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2014, for the purpose of improving infrastructure facilities in the States of Kosrae, Chuuk, Pohnpei and Yap and as Infrastructure Matching Fund, for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$1,200,000 is hereby appropriated

2 from the General Fund of the Federated States of Micronesia for

3 the fiscal year ending September 30, 2014. The funds

4 appropriated under this section shall be used to fund the

5 improvement of infrastructure facilities in the States of Yap,

6 Kosrae, Pohnpei and Chuuk and as Infrastructure Matching Fund

7 (IMF).

16	Section 2. <u>Allotment and management of funds and lapse</u>	<u>date</u> .
17	All funds appropriated by this act shall be allotted, managed	d,
18	administered and accounted for in accordance with applicable	laws,

including, but not limited to, the Financial Management Act of 1 2 1979. The allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for 3 the purpose specified in this act, and that no obligations are 4 incurred in excess of the sum appropriated. The allottee of the 5 funds appropriated under subsection 1(a) of this act shall be the 6 7 Governor of Yap State or his designee. The allottee of funds 8 appropriated under subsection 1(b) shall be the Governor of Kosrae 9 State or his designee. The allottee of funds appropriated under subsection 1(c) of this act shall be the Governor of Pohnpei State 10 11 or his designee. The allottee of funds appropriated under subsection 1(d) of this act shall be the Governor of Chuuk State 12 or his designee. The authority of the allottee to obligate funds 13 14 appropriated by this act shall lapse on September 30, 2015. 15 Section 3.
