## A BILL FOR AN ACT

To appropriate a supplemental budget of \$620,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2015, by amending sections 1 and 3 of Public Law No. 18-89, as amended by Public Law No. 18-102 to provide funding for the operations of the legislative branch of the National Government of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 18-89, as amended by

2 Public Law No. 18-102, is hereby further amended to read as follows:

3 "Section 1. <u>Purpose</u>. The purpose of this act is to

4 appropriate the sum of [90,936,665] 91,556,665 from the

5 General Fund of the Federated States of Micronesia for the

fiscal year ending September 30, 2015, for the purpose of

funding the operations of all branches of the National

8 Government of the Federated States of Micronesia, its

9 agencies, various programs, grants, subsidies and

10 contributions and Capital and Human Resources Development.

11 The National Government's share of the Amended Compact funds

has been reduced to zero except that the National Government

will retain ten percent (10%) of the Supplemental Education

14 Grant funds as is reflected in the budget for the Department

of Education. The budget shall also include appropriations

16 for COM-FSM from sector grants as well as appropriations

17 from amended Compact carry-over funds.

18 Section 2. Section 3 of Public Law No. 18-89 is hereby

amended to read as follows: "Section 3. Operating Expenses of the Legislative 2. The sum of \$[3,849,605] 4,469,605, or so much thereof as 4 may be necessary, is hereby appropriated from the General Fund of 5 the Federated States of Micronesia for the fiscal year ending 6 September 30, 2015, for the operations of the Legislative Branch 7 of the National Government during fiscal year 2015. The sum 8 appropriated by this section shall be apportioned as follows: 9 (1) Speaker and Members. 10 The sum of  $\{[\frac{1}{729}, \frac{771}{771}]$   $2, \frac{149}{771}$ , or so much thereof as may be 11 necessary, for the operations of the Office of the Speaker and 12 Members of the Congress of the Federated States of Micronesia 13 during fiscal year 2015. The sum appropriated herein shall be 14 apportioned as follows: Personnel .....\$ 15 423,290 Travel .....[594,881] 16 734,881 Contractual Services......[851,600] 1,131,600 17 18 OCE ...... -0-Fixed Assets ...... 19 -0-20 (2) Staff Offices. 21 The sum of \$1,279,834, or so much thereof as may be necessary, 22 for the operations of the Congress staff offices during fiscal 23 year 2015.
