A BILL FOR AN ACT

To amend Public Law No. 18-11, by amending section 1 and 2 thereof, to change to use and the allottee of funds previously appropriated therein for the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

, i	I ENACTED BY THE CONGRESS OF THE PEDERATED STATES OF MICRONESTA.
1	Section 1. Section 1 of Public Law No. 18-11 is hereby
2	amended to read as follows:
3	"Section 1. The sum of \$1,680,000, or so much thereof as
4	may be necessary, is hereby appropriated from the General Fund
5	of the Federated States of Micronesia for the fiscal year
6	ending September 30, 2013, to assist the States of Pohnpei and
7	Yap in retiring debt and covering budget shortfalls, PROVIDED
8	THAT the funds appropriated shall not be used for personnel and
9	travel expenses. The funds shall be apportioned as follows:
10	1. Pohnpei State\$ 1,130,000
11	[PROVIDED THAT \$130,000 be used to fund the Micronesian
12	Legal Services Corporation].
13	(a) Micronesian Legal Services Corporation \$ 130,000
14	(b) At large, Pohnpei State roads improvement 250,000
15	(c) Election District No. 1, Pohhpei State roads
16	<u>improvement</u>
17	(d) Election District No. 2, Pohnpei State roads
18	<u>improvement</u>
19	(e) Election District No. 3, Pohnpei State roads

1	<u>improvement\$ 250,000</u>
2	2. Yap State
3	PROVIDED THAT \$50,000 be used for fuel for the Field Trip
4	Ship."
5	Section 2. Section 2 of Public Law No. 18-11 is hereby
6	amended to read as follows:
7	"Section 2. Allotment and management of funds and lapse
8	date. All funds appropriated by this act shall be allotted,
9	managed, administered and accounted for in accordance with
10	applicable laws, including, but not limited to, the Financial
11	Management Act of 1979. The allottee shall be responsible for
12	ensuring that these funds, or so much thereof as may be
13	necessary, are used solely for the purpose specified in this
14	act, and that no obligations are incurred in excess of the sum
15	appropriated. The allottee of the funds appropriated under
16	subsection 1 of section 1 of this act shall be the [Governor of
17	the appropriate state for each of the respective states]
18	President of the Federated States of Micronesia or his
19	<u>designee</u> . The allottee of funds appropriated under subsection
20	2 of section 1 of this act shall be the Governor of the State
21	of Yap or his designee. The authority of the allottee to
22	obligate funds appropriated by this act shall lapse on
23	September 30, 2014.
