THIRD REGULAR SESSION, 2014 CONGRESSIONAL BILL NO. 18-117, C.D.1, C.D.2, C.D.3

AN ACT

To appropriate the sum of \$400,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2014, for the purpose of improving airport terminal facilities in the States of Kosrae, Chuuk, Pohnpei and Yap, for other purposes.

BE I	T ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. The sum of \$400,000 is hereby appropriated from
2	the General Fund of the Federated States of Micronesia for the
3	fiscal year ending September 30, 2014. The funds appropriated
4	under this section shall be used to fund the improvement of
5	airport terminal facilities in the States of Kosrae and Chuuk.
6	Airport Terminal Facility Improvement in Chuuk \$125,000
7	Airport Terminal Facility Improvement in Kosrae 100,000
8	Airport Terminal Facility (passenger processing
9	areas) Improvement in Yap 100,000
10	Airport Terminal Facility Improvement in Pohnpei 75,000
11	Section 2. Allotment and management of funds and lapse
12	date. All funds appropriated by this act shall be allotted,
13	managed, administered and accounted for in accordance with
14	applicable laws, including, but not limited to, the Financial
15	Management Act of 1979. The allottee shall be responsible for
16	ensuring that these funds, or so much thereof as may be
17	necessary, are used solely for the purpose specified in this
18	act, and that no obligations are incurred in excess of the sum

1	appropriated. The allottee of the funds appropriated under
2	this act shall be the respective Governor of each of the
3	States, except the allottee for Pohnpei State's share of
4	Airport funds shall be the Pohnpei Port Authority. The
5	authority of the allottee to obligate funds appropriated by
6	this act shall lapse on September 30, 2015.
7	Section 3. This act shall become law upon approval by the
8	President of the Federated States of Micronesia or upon its
9	becoming law without such approval.
