I transmit the following Congressional Act, which I have signed to become **Public Law No. 18-48:**

Congressional Act No. 18-52, entitled: "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 12-50, AS AMENDED BY PUBLIC LAWS NOS. 12-53, 12-74, 13-1, 13-15, 13-17, 14-65, 14-71, 14-94, 15-15, 15-50, 17-24 AND 18-30, BY AMENDING SECTION 16 THEREOF FOR THE PURPOSE OF CHANGING THE ALLOTTEE OF FUNDS PREVIOUSLY APPROPRIATED THEREIN, AND FOR OTHER PURPOSES."


This Congressional Act changes the allottee of scholarship funds for Chuuk State from the CSCIP to the President and the allottee of Northwest Island Cargo and Passenger Vessel from CSCIP to the General Manager of Northwest Islands Development Authority.

In view of the repeal of the CSCIP through Public Law No. 17-75, which took effect on February 12, 2013, this change of allottee is not only necessary but long overdue.

AN ACT

To further amend Public Law No. 12-50, as amended by Public Laws Nos. 12-53, 12-74, 13-1, 13-15, 13-17, 14-65, 14-71, 14-94, 15-15, 15-50, 17-24 and 18-30, by amending section 16 thereof for the purpose of changing the allottee of funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 16 of Public Law No. 12-50, as amended,  
2 is hereby amended to read as follows:

3               "Section 16. Allotment and management of funds and  
4               lapse date.

5               (1) General Provisions.

6                       (a) All funds appropriated by this act shall be  
7 allotted, managed, administered, and accounted for in  
8 accordance with applicable law, including, but not  
9 limited to, the Financial Management Act of 1979;

10                      (b) The allottees shall be responsible for  
11 ensuring that these funds, or so much thereof as may be  
12 necessary, are used solely for the purposes specified in  
13 this act, and that no obligations are incurred in excess  
14 of the sum appropriated.

15               (2) Allottees. The allottees of the funds  
16 appropriated by this act are as follows:

17                      (a) section 2 - the allottee of these funds  
18 shall be the President of the Federated States of  
19 Micronesia;

1 (b) section 3 - the allottee of these funds  
2 shall be the Speaker of the Congress of the Federated  
3 States of Micronesia;

4 (c) section 4 - the allottee of these funds  
5 shall be the Chief Justice of the Supreme Court of the  
6 Federated States of Micronesia;

7 (d) section 5 - the allottee of these funds  
8 shall be the Public Auditor of the Federated States of  
9 Micronesia;

10 (e) section 6 through 13 - the allottee of these  
11 funds shall be the President of the Federated States of  
12 Micronesia; EXCEPT THAT for the following subsections of  
13 section 6 through 13 of this act, the allottees shall  
14 be:

15 (i) section 8, subsection (5) - the  
16 allottee of these funds shall be the President of the  
17 Federated States of Micronesia;

18 (ii) section 8, subsection (8)(a) through  
19 (8)(d) - the allottee of these funds shall be Chief  
20 Justice of the respective state;

21 (iii) section 13, subsection (1)(a) through  
22 (1)(d) - the allottee of these funds shall be the  
23 President of the College of Micronesia-FSM;

24 (iv) section 13, subsection (2)(a) through  
25 (2)(d) - the allottee of these funds shall be the

1 Governor of the respective state, EXCEPT THAT the  
2 allottee for funds allocated to Chuuk State under  
3 subsection (2)(c) shall be the President of the  
4 Federated States of Micronesia; and


5 (v) Section 13, subsection (15) - the  
6 allottee of these funds shall be the Chief Justice of  
7 the Supreme Court of the Federated States of Micronesia.

8 (vi) Section 13, subsection 17(b) - the  
9 allottee of these funds shall be the General Manager of  
10 Northwest Islands Development Authority.

11 (3) Lapse Dates. The authority of the allottees to  
12 obligate funds appropriated by this act shall lapse as  
13 of September 30, 2003, EXCEPT that funds appropriated  
14 under section 13 of this act shall not lapse."

Section 2. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
