

THIRD SPECIAL SESSION, 2014 CONGRESSIONAL BILL NO. 18-135, C.D.1, C.D.2

PUBLIC LAW No. 18-55

AN ACT

To appropriate the sum of \$400,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2014, for the purpose of providing funding for the athletes and coaches from the four States to participate in the 2014 Micronesian Games and for international cultural festivals, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Purpose. The sum of \$400,000, or so much
2 thereof as may be necessary, is hereby appropriated from the
3 General Fund of the Federated States of Micronesia for the
4 fiscal year ending September 30, 2014, for the purpose of
5 providing funding for the athletes and coaches from the four
6 States to participate in the 2014 Micronesian Games and
7 international cultural festivals. The funds shall be
8 apportioned as follows:

9 (1) State of Yap	\$	100,000
10 (2) State of Kosrae		100,000
11 (3) State of Pohnpei		100,000
12 (4) State of Chuuk		100,000"

13 Section 2. Allotment and management of funds and lapse
14 date. All funds appropriated by this act shall be allotted,
15 managed, administered and accounted for in accordance with
16 applicable laws, including, but not limited to, the Financial
17 Management Act of 1979. The allottee shall be responsible for
18 ensuring that these funds, or so much thereof as may be

1 necessary, are used solely for the purpose specified in this
2 act, and that no obligations are incurred in excess of the sum
3 appropriated. The allottee of the funds appropriated under
4 subsection 1(1) of this act shall be the Governor of the State
5 of Yap or his designee. The allottee of funds appropriated
6 under subsection 1(2) of this act shall be the Governor of the
7 State of Kosrae or his designee. The allottee of funds
8 appropriated under subsection 1(3) of this act shall be the
9 Governor of the State of Pohnpei or his designee. The allottee
10 of funds appropriated under subsection 1(4) of this act shall
11 be the Governor of the State of Chuuk or his designee. The
12 authority of the allottee to obligate funds appropriated by
13 this act shall lapse on September 30, 2014.

PUBLIC LAW NO. 18-55


