Dear Speaker Halbert:

I am returning the following Congressional Act, which I have reluctantly signed to become Public Law No. 18-58:

Congressional Act No. 18-59: "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 17-68, AS AMENDED BY PUBLIC LAWS NOS. 17-71, 17-81, 17-84, 17-89, 17-90, 18-03, 18-10, 18-13, 18-32 AND 18-46, BY AMENDING SECTIONS 4 AND 6 THEREIN, FOR THE PURPOSE OF CHANGING THE USE OF CERTAIN FUNDS PREVIOUSLY APPROPRIATED TO FUND PUBLIC PROJECTS AND SOCIAL PROGRAMS IN THE STATE OF POHNPEI, AND FOR OTHER PURPOSES."

This Act shares common characteristics with previous public project Acts that I have vetoed or returned without signature, namely that there was no public hearings or committee reports and there have been multiple amendments to the original appropriations, i.e., 10 subsequent amendments to the original Act. However, this Act finally appropriates the money that the State of Pohnpei owes to FEMA and makes me the allottee. I cannot in good conscience ignore the long-outstanding debt owed by Pohnpei to this organization that stepped in and assisted when Pohnpei needed it most.

Notwithstanding the defects in the appropriation process that I mention above, I reluctantly return this Act to you with my signature.

19	Section 2. Section 6 of Public Law No. 17-68, as amended by
20	Public Laws Nos. 17-71, 18-03 and 18-13, is here by further
21	amended to read as follows:
22	"Section 6. Allotment and management of funds and lapse
23	date. All funds appropriated by this act shall be
24	allotted, managed, administered and accounted for in
25	accordance with applicable laws, including, but not

limited to, the Financial Management Act of 1979. The
allottee shall be responsible for ensuring that these
funds, or so much thereof as may be necessary, are used
solely for the purpose specified in this act, and that
no obligations are incurred in excess of the sum
appropriated. The allottee of the funds appropriated
under section 2 of this act shall be the Governor of Yap
State. The allottee of funds appropriated under
sections 3 and 4 of this act shall be the President of
the Federated States of Micronesia or his designee,
EXCEPT THAT the allottee of funds appropriated under
subsection 1 of section 3 of this act shall be the
Governor of Kosrae; the allottee of funds appropriated
under subsections $3(2)(j)$ , $(k)$ , $(1)$ , $(m)$ , $(n)$ , $(0)$ , $(p)$ ,
(q), $(r)$ , $(s)$ , $(t)$ , $(u)$ , $(v)$ , $(w)$ , $(x)$ , $(y)$ , $(z)$ , $(aa)$ ,
(ab), (ac), (ad), (ae), (af), (ag) and (ah) of section 3
of this act shall be the Mayor of Lelu Municipal
Government or his designee; the allottee of funds
appropriated under subsection 1 of section 4 of this act
shall be the Governor of Pohnpei State and the allottee
of funds appropriated under subsections 4(c)(xxiii) and
4(c)(xxiv) of section 4 of this act shall be the
Meninkeder lapalap, Madolenihmw Municipal Government.
The allottee of funds appropriated under subsection 5(1)
of this act shall be the President of the Federated

States of Micronesia or his designee. The allottee of
funds appropriated under subsection 5(2)(a) and 5(2)(c)
of this act shall be the Governor of Chuuk State or his
designee. The allottee of funds appropriated under
subsection 5(2)(b) of section 5 of this act shall be the
Mortlock Islands Development Authority. The allottee of
funds appropriated under subsection 5(2)(d) of section 5
of this act shall be the Southern Namoneas Development
Authority or its designee. The allottee of funds
appropriated under subsection 5(2)(e) of section 5 of
this act shall be the Faichuk Development Authority or
its designee. The allottee of funds appropriated under
subsection 5(2)(f) of section 5 of this act shall be the
Northwest Island Development Authority. The authority
of the allottee to obligate funds appropriated by this
act shall lapse on September 30, 2014."
