
I am pleased to transmit the following Congressional Act, which I have signed to become Public Law No. 18-06:



PUBLIC LAW No. 18-06

AN ACT

To further amend section 934 of title 54 of the Code of the Federated States of Micronesia, as amended by Public Law No. 17-83, to extend a deadline set for the implementation of the tax reform, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 934 of title 54 of the Code of the
2 Federated States of Micronesia, as and amended by Public Law No.
3 17-83, is hereby further amended to read as follows.
4 "Section 934. If any of the four states of the
5 Federated States of Micronesia have not passed into law
6 value added tax legislation as of midnight September 30,
7 2013, this act is null and void."

8 Section 2. This act shall become law upon approval by the
9 President of the Federated States of Micronesia or upon its
10 becoming law without such approval.
