## AN ACT

To further amend Public Law No. 16-62, as amended by Public Laws Nos. 16-71, 17-05, 17-18, 17-29 and 17-47, by amending sections 4 and 6 thereof, to change the use, allottee and lapse date of certain funds previously appropriated therein to fund public projects and social programs in the States of Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

4	Section 2. Section 6 of Public Law No. 16-62, as amended
5	by Public Laws Nos. 16-71, 17-05 and 17-18, is hereby further
6	amended to read as follows:
7	"Section 6. Allotment and management of funds and
8	lapse date. All funds appropriated by this act shall
9	be allotted, managed, administered and accounted for
10	in accordance with applicable law, including, but not
11	limited to, the Financial Management Act of 1979.
12	The allottee shall be responsible for ensuring that
13	these funds, or so much thereof as may be necessary,
14	are used solely for the purpose specified in this
15	act, and that no obligations are incurred in excess
16	of the sum appropriated. The allottee of funds
17	appropriated under sections 2 and 4 of this act shall
18	be the President of the Federated States of
19	Micronesia or his designee, PROVIDED THAT the
20	allottee of funds appropriated under subsection
21	4(1)(c) of this act shall be the Pohnpei
22	Transportation Authority, the allottee of funds
23	appropriated under subsection 4(2)(c) of this act
24	shall be the Secretary of the Department of Resources
25	and Development or his designee, the allottee of

1	funds appropriated under subsections 4(3)(b), 4(3)(c)
2	and 4(3)(j) of this act shall be the Luhkenmoanlap of
3	Kitti Municipal Government and the allottee of funds
4	appropriated under subsection 4(3)(i) of this act
5	shall be the Meninkeder Lapalap of Madolenihmw
6	Municipal Government. The allottee of funds
7	appropriated under section 3 of this act shall be the
8	Governor of Yap State. The allottee of funds
9	appropriated under subsections 5(1) and 5(3) shall be
10	the Governor of Chuuk or his designee. The allottee
11	of funds appropriated under subsection 5(2) of this
12	section 5 of this act shall be the Mortlocks Islands
13	Development Authority. The allottee of funds
14	appropriated under subsection 5(4) of section 5 of
15	this act shall be the Executive Director of the
16	Southern Namoneas Development Authority. The
17	allottee of funds appropriated under subsection 5(5)
18	of section 5 of this act shall be the Faichuk
19	Development Authority. The allottee of funds
20	appropriated under subsection 5(6) of section 5 of
21	this act shall be the Northwest Development
22	Authority. The funds appropriated by this act shall
23	lapse on September 30, 2014."
